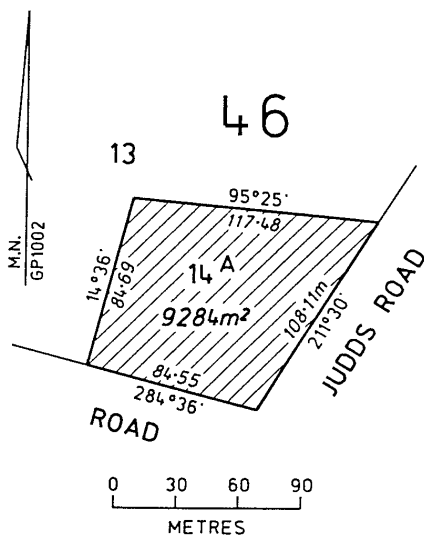

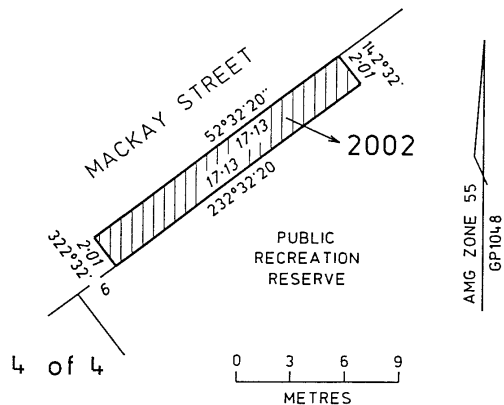

3. Report on outstanding areas where further reforms should be implemented to improve health outcomes.
4. Recommend an implementation framework for future reforms, with desired health improvements in the Victorian community.

In conducting the inquiry, the Committee is required to seek the views of relevant Commonwealth and State Government Departments, Local Government peak bodies, health organisations and industry groups.

The Committee is required to report to the Parliament by 15 December 2003.
