## Administrative Arrangements Act 1983

### ADMINISTRATIVE ARRANGEMENTS ORDER (NO. 180) 2002

The Governor in Council makes the following Order:

**1. Title**

This Order is called the Administrative Arrangements Order (No. 180) 2002.

**2. Authorising provision**

This Order is made under section 3 of the **Administrative Arrangements Act 1983**.

**3. Commencement**

This Order takes effect on 6 August 2002.

**4. Definitions**

In this Order —

“**Body**” means Minister;

“**instrument**” includes contract and agreement;

“**Old Body**” means a Body specified in Column 1 of an item in the Schedule;

“**New Body**” means a Body specified in Column 3 of an item in the Schedule;

“**Schedule**” means Schedule to this Order;

“**transaction**” includes —

- (a) agreement, bond, contract, deed or other consensual arrangement; and
- (b) action, appeal, arbitration, prosecution or other legal proceeding; and
- (c) assignment, charge, lease, mortgage, transfer or other dealing with property; and
- (d) loan, guarantee, indemnity or other dealing with money; and
- (e) approval, consent, delegation, direction, licence, Order, permit, requirement or other authority; and
- (f) notice; and
- (g) any other act, entitlement or liability at law.

**5. Construction of references**

(1) In respect of each item in the Schedule, a reference to an Old Body —

- (a) in a provision of an Act specified in Column 2 of the Schedule; or
- (b) in a statutory instrument or other instrument made under an Act specified in Column 2 of the Schedule; or
- (c) in respect of any other matter or thing done under a provision of an Act specified in Column 2 of the Schedule —

is deemed to be a reference to the New Body.

(2) A reference in the Order in Council, dated 2 February 1988, and published in the Government Gazette on 10 February 1988 and made under section 16 of the **Planning and Environment Act 1987**, to the Minister for Education or the Minister for Education and Training, is deemed to be a reference to the Minister for Education and Training and the Minister for Education Services.

**6. Saving of existing transactions**

If a transaction happened in relation to an Old Body before this Order takes effect —

- (a) this Order does not affect the validity or continuity of the transaction; and
- (b) the transaction shall continue and may be completed in relation to the New Body in the same way as it would have been continued and may have been completed in relation to the Old Body if this Order had not been made.
