MELBOURNE CRICKET GROUND (OPERATION OF FLOODLIGHTS) ORDER No. 5/2002

I, Justin Madden, Minister for Sport and Recreation, make the following Order:

1. Title

This Order may be cited as the Melbourne Cricket Ground (Operation of Floodlights) Order No. 5/2002.

2. Objectives

The objectives of this Order are to –

- (a) specify the days and times during which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be used; and
- (b) specify the purposes for which the floodlights may be used on those days; and
- (c) make provision in relation to vehicle entry into the Yarra Park Reserve.

3. Authorising provision

This Order is made under section 3 of the Melbourne Cricket Ground Act 1984.

4. Floodlights may be used on certain days at certain times and for certain purposes

The floodlights affixed to the floodlight towers at the Melbourne Cricket Ground may be used -

- (a) for the purpose of joining with the Herald Sun in the "Shine On" promotion to commemorate the World Trade Centre disaster on 11 September 2002 between 8.30 a.m. and 10.00 a.m.;
- (b) for the purpose of permitting training on 11 September 2002 between 5.30 p.m. and 8.30 p.m. for the Australian Football League Finals; and
- (c) between 8.00 a.m. and 8.30 p.m. for the purpose of aligning, testing or repairing of the floodlights on 9 September 2002 and 11 September 2002.

5. Yarra Park Reserve – Entry of Vehicles

Vehicular traffic is not permitted to enter into Yarra Park Reserve by way of Vale Street after 5.00 p.m. on any day on which the floodlights affixed to the floodlight towers at the Melbourne Cricket Ground are permitted to be used for the purposes specified in clause 4(a), (b) and (c).


Commonwealth Games Arrangements Act 2001

DESIGNATED ACCESS AREA ORDER

In accordance with section 16 of the **Commonwealth Games Arrangements Act 2001** ("the Act") as the Minister administering the Act, I declare that the following area of land adjacent to a Commonwealth Games venue (Melbourne Cricket Ground) to be a designated access area, being:

all of the land shown cross hatched on the attached drawing numbered 1558015 titled "MCG Redevelopment Access Zone Perimeter Definition" for the period commencing at 12.01 a.m. on 10 September 2002 and ending at 11.59 p.m. on 30 September 2004.

This Notice shall take effect on and from the date of its publication in the Government Gazette.


TEMPORARY ROAD CLOSURE BRUNTON AVENUE

In accordance with section 45 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), as the Minister administering the Act I hereby temporarily close part of Brunton Avenue adjacent to the MCG to traffic to enable necessary demolition and construction works associated with the Melbourne Cricket Ground Redevelopment Project which is a project to develop facilities at a Commonwealth Games venue.

The temporary closure of such part of the road known as Brunton Avenue, Melbourne shown cross hatched on the attached plan for the following period:

• Commencing at 12.01 a.m. on 29 September 2002 and ending at 11.59 p.m. on 30 September 2004 temporary partial closure to facilitate the redevelopment in accordance with the approved Traffic Management Plan.

This Order shall take effect on the date of its publication in the Government Gazette.
