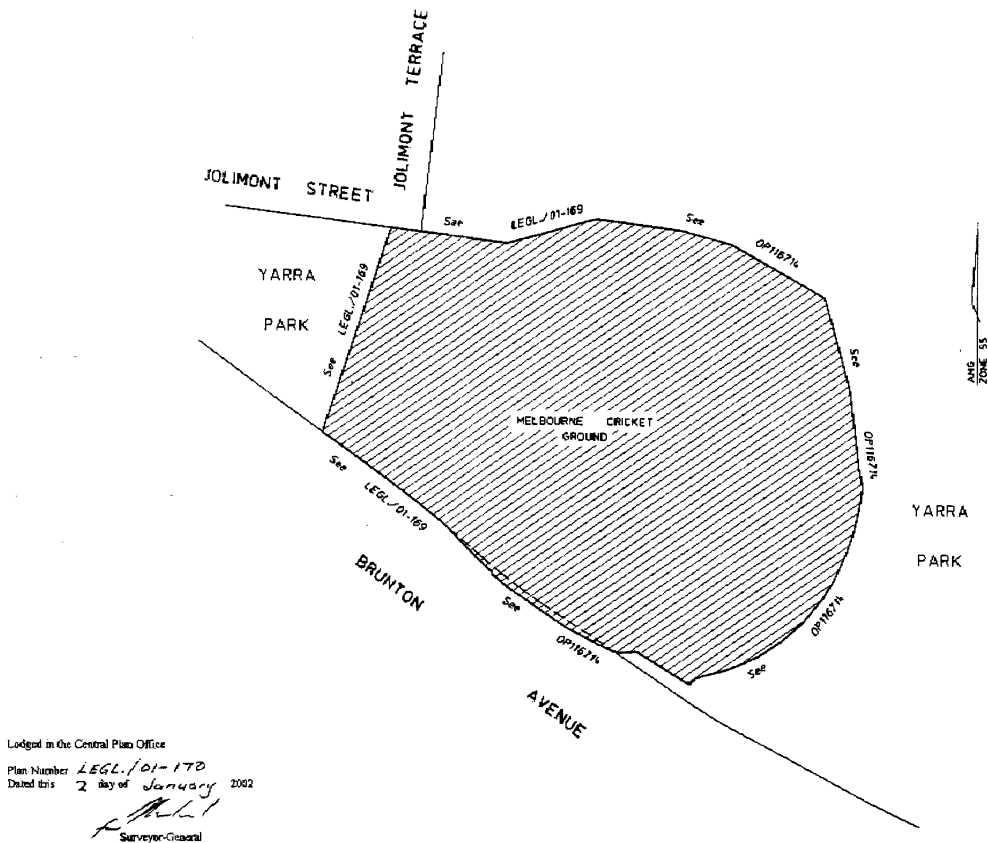

COMMONWEALTH GAMES VENUE ORDER

In accordance with section 14 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), as the Minister administering the Act, I declare the following area of land to be a permanent Commonwealth Games venue to which the Act applies:

the whole of the area of Melbourne Cricket Ground, as defined in the **Melbourne Cricket Ground Act 1933** as being included in or forming part of the land reserved under Order in Council dated 20 February 1934 and referred to in the Crown Grant entered into the Register Book of the Office of Titles in Volume 5925, Folio 1184828 and hatched on plan of survey numbered LEGL./01/170 and lodged in the Central Plan Office.

COMMONWEALTH GAMES PROJECT ORDER

In accordance with section 15 of the **Commonwealth Games Arrangements Act 2001** (“the Act”), as the Minister administering the Act, I declare the Melbourne Cricket Ground Redevelopment Project a project to develop facilities at a Commonwealth Games venue to be a project to which the Act applies and I authorise the development of that project for the period commencing 1 September 2002 until 31 December 2006.

In accordance with sections 17 and 26 of the Act I specify that the Secretary to the Department of Innovation, Industry and Regional Development, being a body corporate constituted under section 41A of the **Project Development and Construction Management Act 1994**, is the person or body responsible for managing or developing the Commonwealth Games project to which this Order applies.

This Order shall take effect from the date of its publication in the Government Gazette.
