### Accident Compensation (WorkCover Insurance) Act 1993 WORKCOVER INSURANCE PREMIUMS ORDER (NO. 9) 2001/2002

Under and for the purposes of Item 1 of Schedule 3 to the WorkCover Insurance Premiums Order (No. 9) 2001/2002, the Victorian WorkCover Authority has determined that the values of  $F_0^{c}$ ,  $F_1^{c}$  and  $F_2^{c}$ , for the purposes of calculating the Experience Factor E, for a period of coverage of a workplace, are respectively the relevant numbers specified in the following Table, opposite the authorised agent which calculated the costs of claims of the workplace:
