#### MEMORANDUM OF UNDERSTANDING BETWEEN

#### THE ESSENTIAL SERVICES COMMISSION AND THE OFFICE OF GAS SAFETY

THIS MEMORANDUM is made on 30 September 2003

**PARTIES:** ESSENTIAL SERVICES COMMISSION (the "Commission")

and OFFICE OF GAS SAFETY (the "Office")

#### BACKGROUND:

- A. The Office is a prescribed agency for the purposes of the **Essential Services Commission Act 2001**.
- B. The parties have entered into this memorandum of understanding to provide for consultation between them and the integration and co-ordination of their regulatory and other activities, in accordance with sections 15 and 16 of the **Essential Services Commission Act 2001**.

#### OPERATIVE PROVISIONS:

##### 1. Definitions

In this memorandum, including the background:

"GS Act" means the **Gas Safety Act 1997** (Vic);

"ESC Act" means the **Essential Services Commission Act 2001** (Vic);

"prescribed agency" has the same meaning as in the ESC Act;

"regulated industry" has the same meaning as in the ESC Act.

**2. Objectives and purpose of this memorandum**

This memorandum seeks to:

- (a) ensure that the regulatory and decision making processes of the parties in relation to regulated industries are closely integrated and better informed;
- (b) avoid overlap or conflict between regulatory schemes (either existing or proposed) affecting regulated industries;
- (c) provide for sharing information between the parties in the context of their respective roles in relation to regulated industries;
- (d) promote the adoption of a best practice approach to regulation; and
- (e) assist in ensuring that the Commission is in a position to have regard to relevant gas safety legislation and regulatory practice in its decision making in relation to regulated industries.

**3. The role of the Commission**

3.1 The Commission currently has functions relating to the economic regulation of the electricity, gas, ports, grain handling, freight rail, taxi, hire car, tow truck, statutory insurance and water industries. Its specific functions are:

- (a) to perform such functions as are conferred by the ESC Act and the relevant legislation under which a regulated industry operates;
- (b) to advise the relevant Minister on matters relating to the economic regulation of regulated industries, including reliability issues;
- (c) when requested by the Minister to do so, to conduct an inquiry into any systemic reliability of supply issues related to a regulated industry or other essential service specified by the Minister in the request;
- (d) to conduct inquiries and report under the ESC Act on matters relating to regulated industries;
- (e) to make determinations in accordance with the ESC Act;
- (f) to make recommendations to the Minister as to whether an industry which provides an essential service should become a regulated industry or whether a regulated industry should continue to be a regulated industry;
- (g) to conduct public education programs for the purpose of promoting its objectives under the ESC Act and the relevant legislation and in relation to significant changes in the regulation of a regulated industry;
- (h) to advise the Minister in relation to any other matter referred to the Commission by the Minister; and
- (i) to administer the ESC Act.

3.2 The Commission's primary objective in performing those functions is to protect the long-term interests of Victorian consumers with regard to the price, quality and reliability of essential services. In seeking to achieve that primary objective, the Commission must have regard to the following facilitating objectives:

- (a) to facilitate efficiency in regulated industries and the incentive for efficient long-term investment;
- (b) to facilitate the financial viability of regulated industries;
- (c) to ensure that the misuse of monopoly or non-transitory market power is prevented;
- (d) to facilitate effective competition and promote competitive market conduct;
- (e) to ensure that regulatory decision making has regard to the relevant health, safety, environmental and social legislation applying to the regulated industry;

- (f) to ensure that users and consumers (including low-income or vulnerable customers) benefit from the gains from competition and efficiency; and
  - (g) to promote consistency in regulation between States and on a national basis.
- 3.3 The Commission must also perform its functions and exercise its powers in such a manner as the Commission considers best achieves any objectives specified in the relevant legislation under which a regulated industry operates.
- 4. The role of the Office**
- 4.1 The Office has broad powers in relation to gas safety and the safety of non-automotive use of liquefied petroleum gas (LPG) and other gaseous fuels.
- 4.2 The specific functions of the Office are set out in the GS Act and include:
- (a) the issue of guidelines specifying minimum safety standards for appliances, gas equipment, gas components, gas installations, gas related services and the conveyance, sale, supply, measurement, control and use of gas;
  - (b) the issue of guidelines in relation to the preparation of safety cases;
  - (c) monitoring compliance of appliances, gas equipment, gas components, gas installations, gas related services and the conveyance, sale, supply, measurement, control and use of gas with the specified safety standards;
  - (d) monitoring compliance of gas companies with accepted safety cases;
  - (e) the audit of accepted safety cases to determine the adequacy and effectiveness of those safety cases;
  - (f) administration of the prescribed minimum standards for energy efficiency of gas installations, appliances and components;
  - (g) inspection and testing of gas installations, appliances and components for compliance with the specified minimum standards for energy efficiency;
  - (h) investigation of events or incidents which have implications for gas safety;
  - (i) the provision of advisory and consultative services in relation to gas safety; and
  - (j) consultation with and advise industry and the community in relation to gas safety.
- 5 How the parties will consult**
- 5.1 Where relevant, the Commission will, as early as practicable, consult with the Office:
- (a) in the making of a determination;
  - (b) in the conduct of an inquiry or investigation, after first consulting with the Minister; and
  - (c) in preparing and reviewing the Commission's Charter of Consultation and Regulatory Practice.
- 5.2 The Office will, if requested in writing by the Commission to do so, consult with the Commission:
- (a) in relation to any matter specified by the Commission which is relevant to the Commission's objectives or functions; and
  - (b) in respect of a matter specified by the Commission which may impact on a regulated industry.
- 5.3 Each party having regard to their respective roles in relation to each regulated industry will:
- (a) consult with and involve the other in the performance of any function that has or is likely to have material implications for the other<sup>1</sup>;
  - (b) ensure that such consultation occurs as early as practicable in the parties' regulatory, advisory or decision making processes;
- (c) on request, provide the other with timely advice on regulatory matters for which it is responsible;
- 
1. For example, the Commission proposes to give the Office the opportunity to sit on the Commission's working groups in conducting major reviews or inquiries.

- (d) provide the other with timely relevant information on industries or industry issues for which both parties have some responsibility;
- (e) promptly inform the other of any material changes to its role or to the regulatory arrangements it administers;
- (f) exchange details of annual work programs to the extent that they are relevant to the role of the other;
- (g) provide the other with advance notice of its intention to undertake a major review or activity that will or may have material implications for the other;
- (h) identify opportunities to co-ordinate strategic planning and undertake knowledge sharing initiatives to optimise material understanding of roles and strategic directions;
- (i) identify relevant project officers to allow for the co-ordination of particular regulatory projects; and
- (j) publish this memorandum on its website.

**6. How the parties will manage their relationship and resolve disputes**

- 6.1 Each party will ensure that, at all times while this memorandum is in force, one of its staff members is designated and known to the other as its contact officer for the purposes of this memorandum.
- 6.2 At the date of this memorandum, the contact officer for the Commission is Mr Nicholas Rizos, and the contact officer for the Office is Mr Mike Ebdon. Each party will give notice of any change to its contact officer to the other, promptly after the change is made.
- 6.3 Each party will ensure that its contact officer:
- (a) makes him/herself (or an alternate) available at all relevant times to address any questions, concerns or disputes arising out of the operation of this memorandum which are raised by either party;
  - (b) instigates periodic (and in any event not less than three yearly) reviews of this memorandum directed, in particular, to the potential for improvement in its terms or operation and to the effect (if any) of regulatory change on its terms, operation or utility; and
  - (c) arranges (in conjunction with the other's contact officer) such meetings of appropriate staff of the parties as and when necessary or desirable to facilitate the efficient and effective operation of this memorandum and including, in any event, a meeting of the Chairperson of the Commission and Director of Gas Safety no less frequently than annually.
- 6.4 If there is a dispute between the parties as to the terms or operation of this memorandum, each party will ensure that its contact officer endeavours in good faith to resolve that dispute with the other's contact officer. If, however, a contact officer gives notice to the other party's contact officer of the view that the dispute is unlikely to be resolved by discussions between the contact officers, then each party's contact officer must promptly:
- (a) brief the party's Chairperson of the Commission or Director of Gas Safety (or a nominee of the party's Chairperson or Director) of details of the relevant dispute; and
  - (b) arrange with the other's contact officer for a meeting of the Chairperson of the Commission and Director of Gas Safety (or their respective nominees), with the objective of settling the dispute amicably.



**7. Use and disclosure of information**

- 7.1 The capacity of a party to use or disclose information, or take information into account, is or may be (depending on the nature or source of the information) restricted by law.
- 7.2 If a party discloses information to the other party under this memorandum, the disclosing party may place restrictions on the recipient's use or disclosure of that information, being restrictions it believes in good faith are necessary for compliance with binding restrictions on disclosure. A party receiving information will observe any such restriction noting, however, that this requirement does not limit:
- (a) any other legal obligation of a party relating to the disclosure or use of information; and
  - (b) any right of a party concerning information obtained otherwise than under this memorandum.

Clause 3.6.18 is amended by inserting the words "provided in accordance with clause 3.6.14" at the end of sub-clause 3.6.18(a)(2).

Clause 3.6.18 is amended by deleting clause 3.6.18(b) and substituting the following:

- "(b) Subject to clause 3.6.18(d), if a dispute arises between a *Market Participant* and *VENCORP* during the period between the issue of a *final statement* and the issue of a *revised statement* in accordance with clause 3.6.19(c) concerning either:
- (1) *the settlement amount* stated in a *final statement* provided under clause 3.6.15 to be payable by or to it; or
  - (2) the supporting data provided in accordance with clause 3.6.15, they must each use reasonable endeavours to resolve the dispute within 113 *business days* after the end of the *billing period*.
- (ba) Subject to clauses 3.6.18(b) and 3.6.18(d), disputes in respect of:
- (1) *the settlement amount* stated in a *revised statement* provided under clause 3.6.19 to be payable by or to it; or
  - (2) the supporting data provided in accordance with clause 3.6.19, must be raised within twelve (12) months of the *revised statement* issue date."

Clause 3.6.18 is amended by deleting the reference to “3.6.18” and substituting the reference “3.6.18(ba)” in clause 3.6.18(c).

Clauses 3.6.19(a) and 3.6.19(b) are deleted.

Clause 3.6.19 is amended by deleting clauses 3.6.19(ca) and 3.6.19(cb) and substituting the following:

- “(ca) If, within 12 months of the issue of a *revised statement* under clause 3.6.19(c), *VENCorp* becomes aware of an error in an amount stated in that *revised statement* and in *VENCorp*'s reasonable opinion a *Participant* would be materially affected if a revision to the *revised statement* was not made to correct the error, then *VENCorp* must:
- (1) advise each *Market Participant* likely to be materially affected by the error within five (5) *business days* of *VENCorp* deciding the error is material, and
  - (2) as soon as practicable issue *revised statements* for the relevant *billing period* in accordance with clause 3.6.19(d).
- (cb) If an amount in a *revised statement* issued under clauses 3.6.19(c) or 3.6.19(ca) has been the subject of a dispute and the dispute has been resolved in any way which causes the amount payable to differ from the amount payable in the disputed *revised statement* then *VENCorp* must issue to each *Market Participant* affected by the resolution of the dispute a *revised statement* in accordance with clause 3.6.19(d).”

Clause 3.6.19 is amended by deleting the reference to “3.6.19(a)” and substituting the reference “3.6.19(d)” in sub-clause 3.6.19(d)(2).

Clause 3.6.19 is amended by inserting after clause 3.6.19(d) the following new clause:

- “(e) The statements issued under this clause 3.6.19 must include supporting data for all amounts payable which must be sufficient to enable each *Market Participant* to audit the calculation of the amount payable by or to that *Market Participant*.”

Clause 7.2.5 is amended by deleting clause 7.2.5(c) and substituting the following:

- “(c) the dispute must be referred to the *Adviser* in accordance with clause 7.2.3(a), or to the *Regulator* under clause 7.2.1(c), within twelve months of the issue date of the *settlement statement* or other invoice to which the disputed payment relates;”

Clause 7.2.5 is amended by inserting the words “or other invoice” after the words “*statement*” in clauses 7.2.5(d) and 7.2.5(e).

Clause 7.2.6 is amended by deleting the words “*settlement statement* issued under clause 3.6.15” and substituting the words “*revised statement* issued under clauses 3.6.19(b) or 3.6.19(c)”.

Clause 7.2.6 is amended by deleting the words “revised *settlement*” in clause 7.2.6(a) and substituting the word “*revised*”.

Clause 7.2.6 is amended by deleting the words “*settlement statement*” and substituting the words “*revised statement*” in clause 7.2.6(a).
