MONASH PLANNING SCHEME Notice of Approval of Amendment Amendment C31

The Minister for Planning has approved Amendment C31 to the Monash Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment deletes the Public Acquisition Overlay 1 generally applying to land north of Police Road, Mulgrave and applies a Public Acquisition Overlay 2 to a portion of the site. The Amendment also amends the Schedule to the Public Acquisition Overlay by making the Secretary to the Department of Infrastructure the acquisition authority for the land and defines the purpose of the acquisition as "Southern and Eastern Integrated Transport Project and connecting roads".
