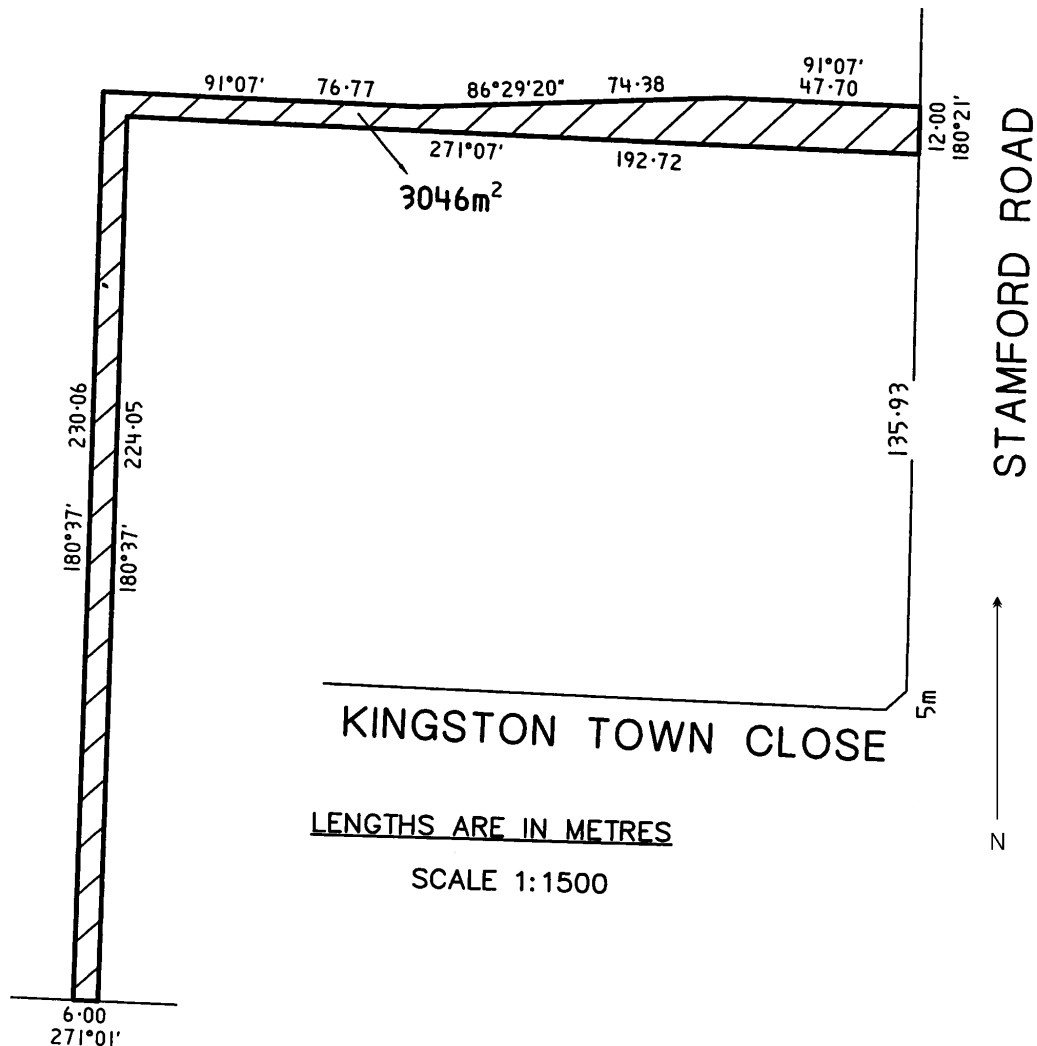

2. resolved to discontinue the road and transfer the land from the road to the Crown.

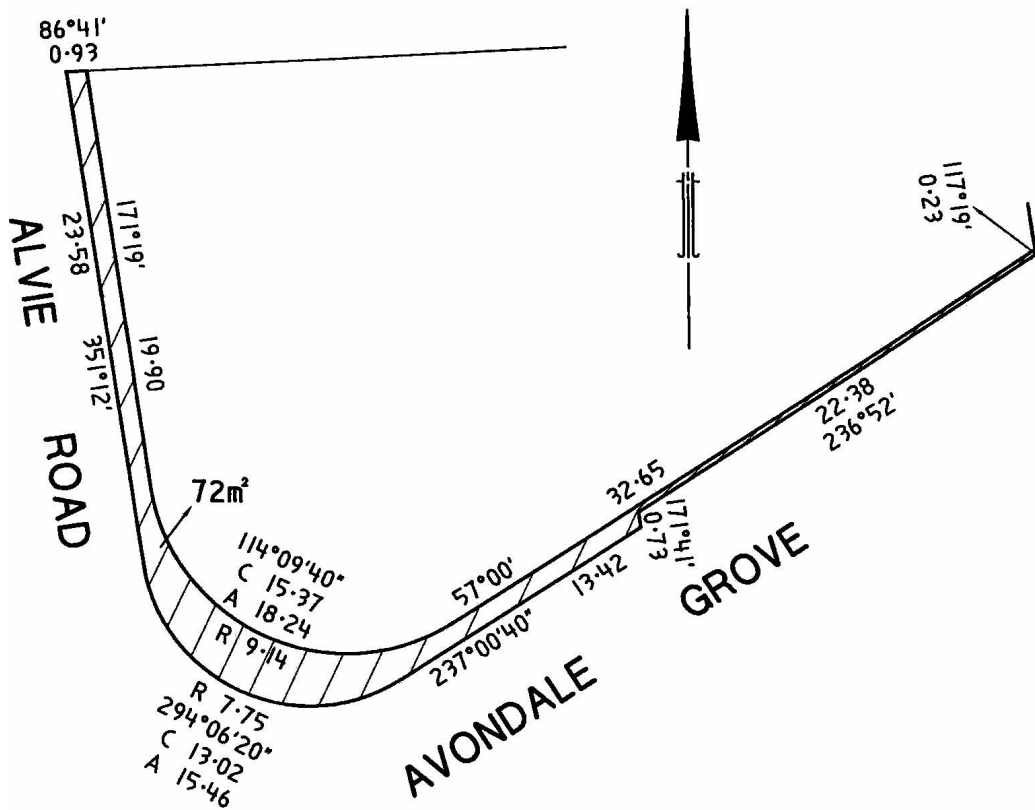

LOCAL LAW NO. 4

Notice of the proposal to make a Local Law

The Council proposes to make a Local Law to make amendments to the Casey Community Local Law No. 2 ("the principle Local Law").

The purposes of the amending Local Law are to ensure that community assets are protected from damage, that community safety and amenity are enhanced and that the administration and enforcement of the principle Local Law is improved.

The general purpose of the amendments is to:

- (a) create new offences for vehicles that use land not intended for the purpose or contrary to the provisions in the Local Law;
- (b) revise the fixed penalty amounts for infringement notice purposes for offences against the Local Law so that they reflect the nature of the offence committed; and
- (c) make a number of minor drafting changes to improve the application of the Local Law.

A copy of the proposed Local Law can be obtained from City of Casey Customer Service Centre, Magid Drive, Narre Warren.

Any person can make a written submission on the proposed Local Law to the Council and submissions received by the Council within 14 days of the publication of this notice will be considered by the Council in accordance with Section 223 of the **Local Government Act 1989**. Amendment C56

The land affected by the Amendment is known as 230 Hallam Road, Hampton Park, being part Lot A on PS 428489C, which is located on the south-eastern corner of Hallam Road and Ormond Road.

The Amendment proposes to apply a Public Acquisition Overlay — Municipal purposes (PAO3) to part of the land to provide for the public acquisition of land required for the future upgrade of the Hallam Road/Ormond Road intersection.
