MORNINGTON PENINSULA PLANNING SCHEME

Notice of Approval of Amendment Amendment C60

The Minister for Planning has approved Amendment C60 to the Mornington Peninsula Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment places Commonwealth land at Point Nepean within a Special Use Zone (Schedule 5 and Schedule 6); places the land within a Heritage Overlay and an Environmental Significance Overlay; places the land in Special Use Zone – 6 within a Vegetation Protection Overlay; excludes land in Special Use Zone – 5 from the Core Planning Provisions in Clause 57; makes the Minister for Planning the responsible authority for the land; and incorporates the 'Point Nepean Heritage Buildings Precinct Incorporated Plan, December 2003'.
