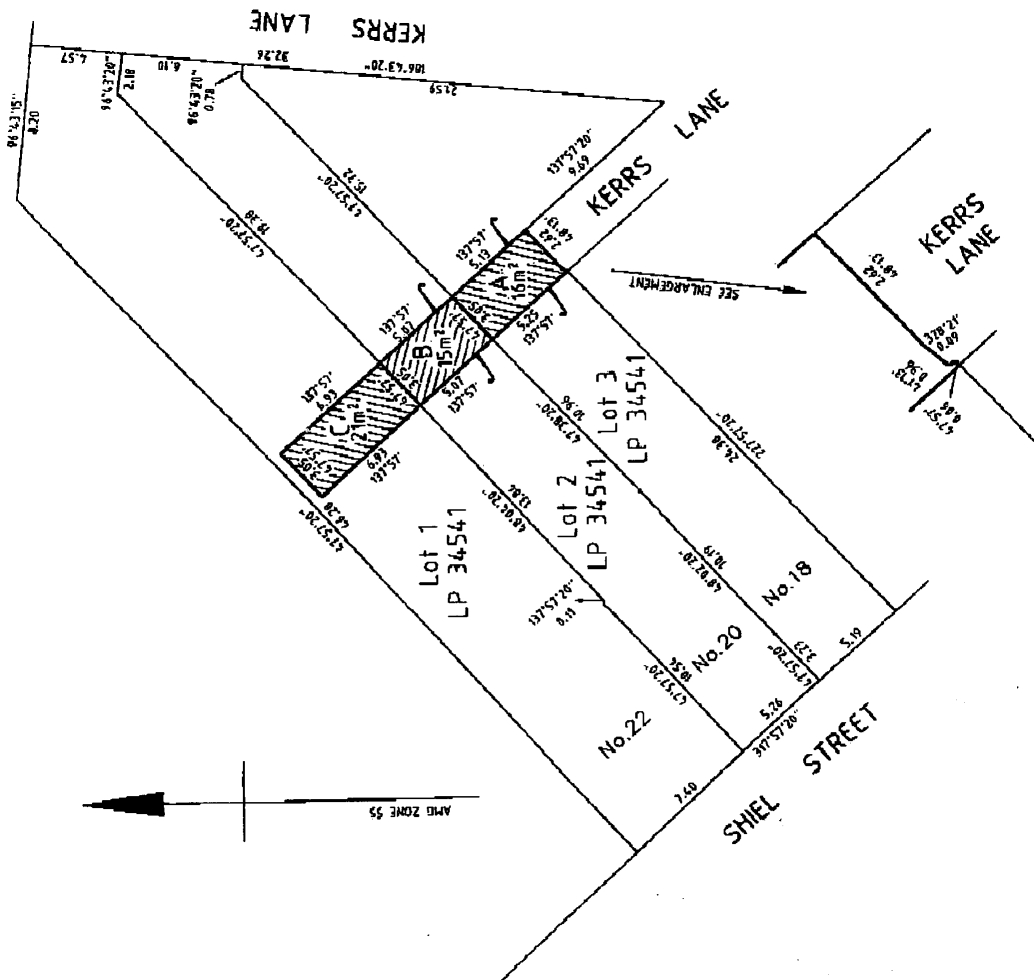

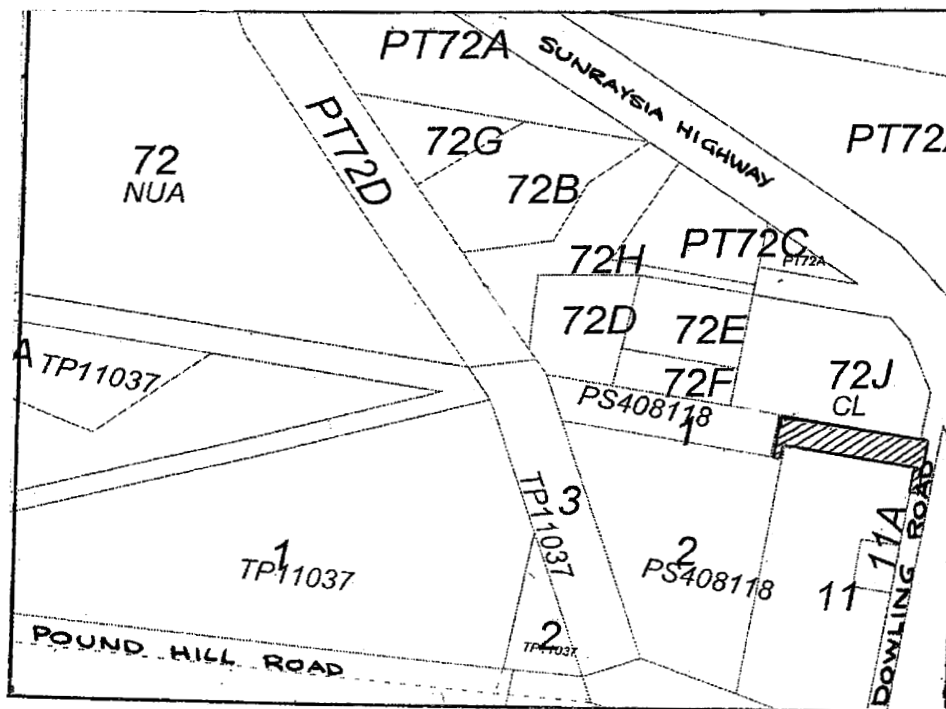

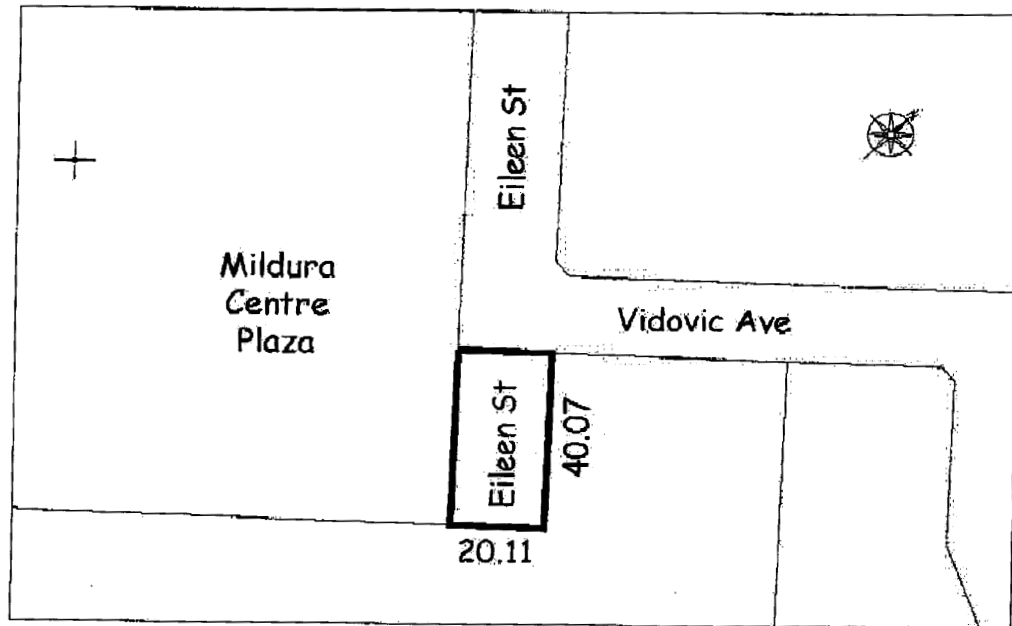

The Local Law formalises Council's functions and powers under the **Local Government Act 1989** or other Act following a review of existing Council Local Laws numbered 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 15, 16 and 17. Local Law number 14 Processes of Municipal Government (Meetings and Common Seal) remains unaltered.

The objectives of the Hindmarsh Local Law are:-

- (a) to enable Council to regulate the use of municipal buildings and provide minimum standards of behaviour in municipal buildings;
- (b) to regulate and provide minimum standards of behaviour at reserves, on roads or in public places and to enable people to enjoy the use of reserves without nuisance or disturbance from other people;
- (c) to promote the health and wellbeing of the people living in the municipal district and to provide a safe and healthy environment which gives the residents of the Council's municipal district the opportunity to enjoy a quality of life that meets the general expectations of the community;
- (d) to prohibit, regulate and control activities which may be dangerous, unsafe, detrimental or undesirable to the quality of life in an environment of Council's municipal district;
- (e) to facilitate the provision of general public services, health and other community services, property services, recreational and cultural services, and other services in a way which enhances the environment and quality of life in the Council's municipal district;

- (f) to control nuisance caused by noise, odour and smoke emissions, and other discharges to the environment which may adversely affect enjoyment of life, health, safety and welfare of persons within Council's municipal district;
- (g) to establish, in a way which is consistent with and for the further achievement of the objectives specified in Clauses 101 (c) to (f) above, a means to prohibit, regulate and control the activities and circumstances associated with:
 - (i) camping on roads and land;
 - (ii) the abandonment of vehicles;
 - (iii) the unlawful obstruction, parking and standing of vehicles;
 - (iv) the lighting of fire in the open air;
 - (v) smoke emissions, particularly emissions from burning materials;
 - (vi) the use of recreational vehicles, particularly recreational vehicles which are not used on appropriate land or reserves or which emit excessive noise or air pollution;
 - (vii) fire hazards;
 - (viii) dangerous and unsightly land;
 - (ix) aquatic facilities;
 - (x) animals, including animal numbers and the keeping and control of animals;
 - (xi) disposal of waste;
 - (xii) protection of public assets from interference or damage;
 - (xiii) aquatic facilities;
 - (xiv) street trading and collections;
 - (xv) practice of soliciting and collecting gifts of money or subscriptions;
 - (xvi) road closures;
 - (xvii) use of streets and public places by persons dealing in goods;
 - (xviii) shopping trolleys;
 - (xix) skateboards;
 - (xx) dogs and cats;
 - (xxi) identification of premises;
 - (xxii) vegetation;
 - (xxiii) obstructions.
- (h) to provide a system for applying for Permits where a Permit is required;
- (i) to regulate the movement and droving of livestock through and within the municipal district and the grazing of livestock within the municipal district;
- (j) to minimise any damage to road pavements, formations, drainage, vegetation and surrounding areas arising from livestock;
- (k) to minimise the spread of livestock disease and noxious weeds in the municipal district;
- (l) to provide for the welfare of livestock when being driven, grazed or moved;
- (m) to alert other road users to the presence on roads of livestock in the municipal district in the interests of safe use of roads;
- (n) to regulate the adequacy of fencing of livestock;
- (o) to put in place mechanisms for rectifying inadequate fencing;
- (p) to fix fees or charges relating to the impounding of livestock and all other costs incidental thereto and for road use by livestock within the municipal district;
- (q) to enter arrangements with neighbouring councils relating to impounding, collecting trespassing livestock, housing and releasing those livestock;

- (r) to regulate skating activities in declared areas of the municipal district;
- (s) to provide for the administration of the Council's powers and functions;
- (t) to provide generally for the peace, order and good government of the municipal district.

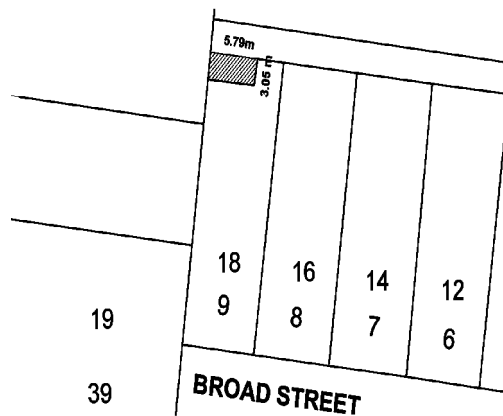

The application for exemption is to enable the applicant to offer and grant fully funded industry scholarships to suitable female engineering university students who have just completed their Industry Based Learning (IBL) placement with the applicant, for completion of their studies ("the scholarship programme").

Upon reading the material submitted in support of the application including the affidavit of Sue Harrison, the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 14, 42, 100 and 195 of the Act to enable the applicant to offer and grant fully funded industry scholarships to suitable female engineering university students who have just completed their Industry Based Learning (IBL) placement with the applicant, for completion of their studies ("the scholarship programme").

In granting this exemption the Tribunal noted:

- the intent of the scholarship program is to offer undergraduate scholarships to deserving Industry Based Learning (IBL) engineering university students at the end of their placement at Venture Industries. The scholarship program is intended to attract high calibre graduate professionals into the organisation and to further advance our Equal Opportunity for Women in the Workplace Program.
- A maximum of two (2) scholarships of the value of \$5,000.00 of education fees will be available per year. One scholarship each year is intended to be offered to a high calibre female student.
- The applicant is an automotive components manufacturer. As is the case among many organisations in the automotive manufacturing industry, the applicant has a technically focussed workforce, which traditionally attracts male employees. This is an issue that the Company seeks to address through strategies such as its Equal Opportunity for Women in the Workplace program (EOWA).

- The applicant currently employs a limited number of professional females and of those most are engineers. During the 2001 to 2002 EOWA reporting period, the percentage of female professionals dropped from twenty-three (23) percent to eighteen (18) percent, due to both an increased requirement for engineers and the difficulties experienced in recruiting female engineers. The applicant moved from 6 female and 20 male engineers to 9 females and 40 males.
- The applicant has been attempting to improve the numbers of female employees across all levels and classifications/roles in the organisation for a number of years. In relation to female engineers in particular however, the pool of available applicants is small and competition with larger employers is fierce.
- The applicant has attracted a limited number of applications from suitably qualified female candidates, but has then been unable in many cases to compete with offers made by other employers.
- The availability of scholarships to female engineers would increase the attractiveness of engineering as a career prospect to women generally and therefore increase the number of females studying engineering, increasing pool of available applicants.
- It is in the public interest that a broader scope of career opportunities is provided to females, including employment in traditionally male-dominated professions such as engineering, promoting equality of opportunity.

The purpose of these extension Regulations is to ensure that regulatory coverage of the hazard of noise-induced hearing loss will be maintained until replacement Regulations are made. All the provisions of the current Noise Regulations continue to apply.

The Noise Regulations 1992, which were due to expire on 1 February 2003, are currently undergoing a review to ascertain their effectiveness and appropriateness in meeting the Government's objective to reduce the incidence of noise-induced hearing loss in the workplace. Because of the number of industries affected, consultation is required with a wide range of stakeholders. Further time is therefore required to complete the review and preparation of replacement Regulations.
