PROPOSED RETAIL LEASES REGULATIONS 2003

Regulatory Impact Statement

Notice is given in accordance with Section 11 of the **Subordinate Legislation Act 1994**, that a Regulatory Impact Statement (RIS) has been prepared in relation to the proposed Retail Leases Regulations 2003.

The proposed Retail Leases Regulations 2003 are to be made under the proposed **Retail Leases** Act 2003, which is currently before Parliament and is due to commence operation by 1 May 2003.

The objectives of the proposed regulations include the establishment of an occupancy cost threshold as a determinant of coverage under the Act and to provide a disclosure statement to ensure an equitable distribution of various classes of expenses between the landlord and the tenant.

The RIS also includes information on a proposed Ministerial determination to exclude commercial tenants in commercial office buildings from coverage under the Act.

The RIS considers the proposed regulations and examines regulatory alternatives. The cost benefit analysis in the RIS demonstrates that the benefits of the proposed regulations outweigh the costs, and are greater than the alternatives.
