Crown Land (Reserves) Act 1978

REVOCATION OF TEMPORARY RESERVATIONS

The Governor in Council under section 10 of the **Crown Land (Reserves) Act 1978** revokes the following temporary reservations:—

SANDHURST — The land in the Parish of Sandhurst (area 33.04 hectares) deemed to be temporarily reserved as a site for public purposes (La Trobe University) pursuant to section 18 (2) of the **La Trobe University (Amendment) Act 1993**, so far only as the portion containing 27.06 hectares being Crown Allotment 2003, Parish of Sandhurst as indicated by hatching on plan published in the Special Government Gazette on 22 October 2002. — (Rs 5197).

SANDHURST — The temporary reservation by Order in Council of 28 September 1993 of an area of 1.118 hectares of land being Crown Allotment 260Y3, Parish of Sandhurst as a site for State Technical College purposes. — (Rs 8328).

SANDHURST — The temporary reservation by Order in Council of 23 February 1954 of an area of 1.358 hectares of land in the Parish of Sandhurst as a site for State School purposes. — (Rs 7227).

Crown Land (Reserves) Act 1978

INCORPORATION OF COMMITTEE OF MANAGEMENT OF THE SOUTHBANK CONTEMPORARY ARTS CENTRE RESERVE

The Governor in Council under Section 14A(1) of the **Crown Land (Reserves) Act 1978**, being satisfied that it is in the public interest to declare to be a corporation the Committee of Management appointed under Section 14(2) of the Act of the land described in the schedule hereunder:—

- (a) declares that the Committee of Management shall be a corporation;
- (b) assigns the name “111 STURT STREET SOUTHBANK COMMITTEE OF MANAGEMENT INCORPORATED” to the corporation; and

under Section 14B(3) of the Act, appoints Dennis CARMODY to be Chairperson of the corporation.

SCHEDULE

The lands in the City of South Melbourne, Parish of Melbourne South being Crown Allotments 18 and 18F, Section D and Crown Allotment 2008 [Stratum] temporarily reserved for Cultural, Recreational and Educational purposes by Orders in Council of 22 July 1997 (vide Government Gazette of 24 July 1997 — page 1898) and 29 October, 2002 (vide Government Gazette of 31 October 2002 — page 2934). — (Rs 37032).
