Subordinate Legislation Act 1994 NOTICE OF DECISION Fisheries (Fees, Levies and Royalties)

Regulations 2003

I, Bob Cameron, Minister for Agriculture and Minister responsible for administering the **Fisheries Act 1995**, give notice under section 12 of the **Subordinate Legislation Act 1994** as follows:

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Fisheries (Fees and Levies) Regulation 2003. The RIS was advertised to invite public comment. Nine submissions were received which unconditionally supported the proposed regulations.

I have decided that the proposed regulations should be made without amendment, save for a new inclusion in relation to the assessment of royalties in relation to holders of abalone fishery access licences. This new inclusion is not subject to a RIS, and has a nil net increase or decrease on the royalties payable.
