DOMESTIC (FERAL AND NUISANCE) ANIMALS ACT 1994

On 20 January 2003 Frankston City Council amended the order to Prohibit Areas for Dogs/Cats/Dogs under Effective Control/Dog Free Roam Areas.

In accordance with the provisions of Section 26(2) of the **Domestic (Feral and Nuisance) Animals Act 1994**, Council hereby resolves as follows:

1. Dogs must be under effective control.

The owner of any dog must keep the dog under effective control by means of chain, cord or leash held by the owner and attached to the dog while the dog is in:

- a reserve; or
- a public place.
- 2. Prohibited Areas: Dogs and Cats.
 - 2.1 Dogs are prohibited from entering and/or remaining on all sand and rock areas of Foreshore beaches within the municipality from 1 December to 31 March of each year between the hours of 9.30 am and 7.30 pm.

Dogs are prohibited from the Central Activities District as bounded by Kananook Creek Boulevard, Beach Street, Nepean Highway, Fletcher Road, Cranbourne Road, Baxter Street, Davey Street and Kananook Creek Boulevard South.

Dogs and cats are prohibited from entering or remaining in the total area of the following reserves:

- Langwarrin Flora and Fauna Reserve, McClelland Drive, Langwarrin;
- Bunarong Park, Willow Road, Frankston;
- Studio Park, McClelland Drive, Langwarrin;
- Casuarina Reserve, Casuarina Drive, Frankston;
- Paratea Reserve, Paratea Avenue, Frankston;
- George Pentland Botanic Gardens, Williams Street, Frankston.

Cats are prohibited from the total area of the following reserves:

- Seaford Wetlands, Austin Road, Seaford;
- Seaford Foreshore Reserve, Nepean Highway, Seaford;
- Sweetwater Reserve, Nepean Highway, Frankston;
- Kananook Reserve, Nepean Highway, Seaford;
- Pines Forest Flora and Fauna Reserve, Frankston.

3. Owner's Obligations

A dog may be exercised off a chain, cord or leash in a "Designated Reserve", if the owner:

- carries a chain, cord or leash sufficient to bring the dog under control if the dog behaves in a manner which threatens any person or animal;
- remains in effective voice or hand control of the dog so as to be able to promptly bring the dog under effective control by placing the dog on a chain, cord or leash if that becomes necessary; and
- does not allow the dog to chase, rush at, bite or attack any person or animal.

If the dog if off a chain, cord or leash in a Designated Reserve, the dog must be brought under effective control of the owner by means of a chain, cord or leash if the dog is within 10 metres of:

- the principal location of an organised sporting event;
- a children's play equipment area when play equipment is in use;
- a permanent barbecue or picnic area.

The Overlay seeks to ensure that the development maintains the free passage of floodwaters, minimises flood damage, is compatible with flood hazard and local drainage conditions and will not cause any significant rise in flood level or flow velocity.

EXEMPTION

Application No. A43/2003

The Victorian Civil and Administrative Tribunal (the Tribunal) has considered an application, pursuant to Section 83 of the **Equal Opportunity Act 1995** (the Act) by Hanover Welfare Services Limited.

The application for exemption is to enable the applicant to advertise for and employ female staff and to provide women only accommodation at two of its facilities.

Upon reading the material submitted in support of the application, the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 49, 100 and 195 of the Act to enable the applicant to advertise and employ female staff and provide women only accommodation at two of its facilities.

In granting this exemption the Tribunal noted:

- the Hanover Welfare Services provide support and services to men, women and families experiencing homelessness or at imminent risk of experiencing homelessness in eleven business units;
- of the eleven business units, three provide support services and eight combine support services together with access to accommodation. The accommodation includes either crisis accommodation or transitional housing;
- Hanover Women's Services operates two of the facilities. One is a 15 bed transitional housing facility at 3 Burnett Street, St. Kilda. The other is a crisis accommodation centre of 15 beds at 346 Dandenong Road, East St. Kilda;
- the facilities operated by Hanover Women's Services are designed for vulnerable single women;
- many of the women assisted do not feel safe around men. 95% of the women who are supported have experienced sexual violence with male perpetrators;
- the communal nature of the facilities provided means it would not be possible to provide a secure physically safe space for the women if men are provided with accommodation at the same facility;
- the Tribunal notes that Hanover has made provision for men or men whose gender identify is that of a woman at other facilities which it operates.

The Tribunal hereby grants an exemption to the applicant from the operation of Sections 13, 49, 100 and 195 of the Act to enable the applicant to advertise for and employ female staff and provide women only accommodation

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 6 March 2006.

LICENCE OR MINING LICENCE

The Proposed Regulations amend the Fisheries Regulations 1998 to provide for the determination and payment of compensation in relation to the compulsory cancellation of access licences as a result of a direction under Section 61 (Ministerial Directions) of the **Fisheries Act** 1995 ('the Act').

The Regulations are required by operation of Sections 61(1)(b) and 63 of the Act and therefore the alternatives to Regulation are considered in the context of assessing compensation. It was concluded a formula based model with an independent negotiator was the most desirable.

The objective of the Proposed Regulations is to ensure that where a Ministerial Direction has been issued to cancel licences, licence holders can be assured that their claim for compensation will be assessed under a consistent, fair, reasonable and expeditious process.

The proposed regulatory changes to achieve these objectives provide for:

- 1. a formula which the Secretary must apply in making a determination for compensation (for all classes of transferable and non-transferable access licences, including licences with a quota entitlement);
- 2. an independent negotiator to act as an intermediary between the Secretary and the applicant; and
- 3. various related administrative procedures, specifically a claims application procedure and the manner in which a compensation claim may be paid.
