SECTION 15 NOTICE

Marine Safety Victoria, on the recommendation of Victoria Police, hereby gives notice under subsection 15(2) of the **Marine Act 1988** that for the period from 2000 hours on the 9th of March 2003 up to such time as the vessel Stolt Australia leaves Port of Port Phillip waters:

- a) the operation of vessels, excluding vessels associated with the security and operation of Stolt Australia, and bathing on the waters of the designated Port of Port Phillip are prohibited within 100 metres of the Stolt Australia whilst the vessel is travelling to and from the place of anchorage or berthing;
- b) the operation of vessels, excluding vessels associated with the security and operation of the Stolt Australia, and bathing on the waters of the designated Port of Port Phillip are prohibited within an area lying to the south west of an imaginary line between the light situated at the end of Gellibrand Pier, and the light at the end of Breakwater, to the shoreline. This zone is to remain in force until the vessel departs the berth.
