SECTION 15 NOTICE

Marine Safety Victoria, on the recommendation of Parks Victoria, hereby gives notice under subsection 15(1) of the **Marine Act** 1988 that for the periods:

0830 8 March 2003 to 1800 8 March 2003, 0830 9 March 2003 to 1800 9 March 2003 and 0830 10 March 2003 to 1800 10 March 2003

- (a) bathing and the operation of vessels, excluding those vessels involved with SHQ Boardsport's Big Air Kite Surfing Event, and vessels owned and operated by Parks Victoria, is prohibited on the designated waters of the Port of Port Phillip within a rectangular area bounded on the north by a prolongation of Park Street extending to seaward 200m from the shoreline; bounded on the south by a prolongation of Wellington Street to seaward 200m from the shoreline; bounded on the west by an imaginary line between markers located 200m seaward of the beach; and, bounded on the east by the shoreline of Middle Brighton Beach;
- (b) the vessels involved with the events listed in this Notice are exempted from Clauses 2(a), 2(c), and 4(a) of Notice No.1 made under s.15(2) of the **Marine Act 1988** for the times detailed above.
