NOTICE OF MAKING OF ORDER UNDER SECTION 13 AND ADMINISTRATIVE ARRANGEMENTS ORDER (No. 180) 2002

An Order of the Minister for Education Services was made on 26 February 2003 under sections 13(4) and 13(11) of the Education Act 1958 and Administrative Arrangements Order (No. 180) 2002 amending the transitional provisions in Part D of the constituting Orders of the school councils of the 36 State schools listed in the following Schedules A and B.

In respect of the schools listed in Schedule A, the Order –

- (i) requires the school council election processes to commence no earlier than the start of the school year and to be completed by 31 March in 2003;
- (ii) provides the dates for the expiration and commencement of office of some school council members in 2003; and
- (iii) makes other consequential amendments to Part D of the constituting Order of the school councils.

In respect of the school listed in Schedule B, the Order –

- (i) requires the school council election processes to commence no earlier than the start of the school year and to be completed by 31 March in 2003 and 31 March 2004 respectively;
- (ii) provides the dates for the expiration and commencement of office of school council members in 2003 and 2004; and
- (iii) makes other consequential amendments to Part D of the constituting Order of the school council.
