## **Plant Health and Plant Products Act 1995**

### NOTICE OF EXTENSION

#### Order Prohibiting or Restricting the Entry or Importation of Blueberry Rust into Victoria

I, Bob Cameron, Minister for Agriculture, give notice that the Order in force under section 24 of the **Plant Health and Plant Products Act 1995** prohibiting or restricting the entry or importation of any plant or plant product of *Vaccinium spp.* (including blueberry, cranberry and huckleberry), *Gaylussacia* (black huckleberry) *Rhododendron spp.* (including azalea), *Tsuga* (hemlock), *Lyonia*, *Menziesia*, *Pernettya*, *Hugeria*, *Pieris*, *Leucothoe* and *Oxycoccus* and any agricultural equipment or used package that has been used in association with these species into Victoria to prevent the entry of the exotic disease blueberry rust is extended for a period of 12 months.

The Order prohibits subject to conditions or restricts the entry or importation of any blueberry rust host material, agricultural equipment or used package that has been used in association with the host material so as to prevent the introduction or spread of the exotic disease blueberry rust (*Pucciniastrum vaccinii*) into Victoria.
