Annual Taxi-Cab Licence Fees applicable to Taxi-Cab Licences issued
on or after 16 April 2003

I, Howard Ronaldson, Secretary to the Department of Infrastructure, pursuant to the provisions of section 147B of the **Transport Act 1983**, determine that the following scale of annual fees shall apply to any taxi-cab licence issued on or after 16 April 2003 and which authorises operation of a taxi-cab from places other than the metropolitan taxi-cab zone or outer suburban taxi-cab zone.

Number of taxis in area immediately prior to licence determination (excludes metropolitan and outer suburban)	Annual Fee	
	Conventional taxi	Wheelchair accessible taxi
Above 30	\$4,200	\$2,100
20-29	\$3,750	\$1,870
10-19	\$3,200	\$1,600
5-9	\$2,500	\$1,250
1-4	\$2,000	\$1,000
0	\$1,000	\$500

- In addition to this scale of fees, an additional annual administration fee of \$434 is also payable for each licence.

Note:

Publication of this notice of annual licence fees does not supersede previous gazettal of annual taxi-cab licence fees applicable to taxi licences issued prior to 16 April 2003.
