# ORDER DECLARING A RESTRICTED AREA AT KOONOOMOO FOR THE CONTROL OF QUEENSLAND FRUIT FLY

I, Bob Cameron, Minister for Agriculture, under Sections 20 and 22 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of Queensland Fruit Fly and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

#### 1. Objective

The objective of this Order is to declare a restricted area for the control of Queensland fruit fly at Koonoomoo and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

#### 2. Authorising provisions

This Order is made under Sections 20 and 22 of the **Plant Health and Plant Products Act** 1995.

### 3. Definition

In this Order -

- (a) "Act" means the Plant Health and Plant Products Act 1995; and
- (b) "Queensland fruit fly" means the exotic pest Bactrocera tryoni (Froggart); and
- (c) "Regulations" mean the Plant Health and Plant Products Regulations 1996.

### 4. Restricted area for the control of Queensland fruit fly

The restricted area for the control of Queensland fruit fly is declared to be the areas described in Schedules 1 and 2.

#### 5. Prohibitions, restrictions and requirements

- (1) The removal from the restricted area into any part of Victoria of any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations is prohibited unless the fruit or vegetable is accompanied by a Plant Health Certificate or Plant Health Declaration and in the case of fruit for treatment, packing or processing outside the restricted area, is accompanied by a permit issued by an inspector under Section 21 of the Act.
- (2) The owners and occupiers of land described in Schedule 2 must give access to such land at all times to an inspector, after 24 hours notice is given to the occupier or if the occupier consents to the entry, for the purpose of inspection, placing on such land any lures of traps, applying on such land any spray material or bait and performing any other actions in accordance with Section 52 of the Act which in the opinion of the authorised officer are necessary for the eradication or prevention of the spread of the pest.
- (3) The owners and occupiers of land described in Schedule 2, on instructions from an inspector, must strip fruit from trees, collect and dispose of waste fruit, or treat fruit and vegetables listed as hosts of Queensland fruit fly in Schedule 5 of the Regulations in a manner approved by the Secretary.
- (4) Any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations which is transported through the restricted area, from areas free of Queensland fruit fly, must be transported in accordance with the conditions of a permit issued by an inspector.

#### Schedule 1

The area of land bounded by a line commencing where Cemetery Road meets the Murray River, then in a straight line in a south westerly direction to the intersection of the Murray Valley Highway and Pye Road, then in a southerly direction along Pye Road to the intersection of Pye Road and Healy Road, then in a westerly direction along Healy Road to the intersection of Healy Road and Cottons Road, then in a southerly direction along Cottons Road to the intersection of Cottons Road and McIntyre Road, then along McIntyre Road in a westerly direction to the intersection of McIntyre Road and Campbell Road, then in a southerly direction along Campbell Road to the intersection of Campbell Road and Parnell Road, then in a westerly direction along Parnell Road to the intersection of Parnell Road which becomes Sandmount Road, to the intersection of Sandmount Road and Lorenzs Road, then in a northerly direction along Lorenzs Road to the intersection of Lorenzs Road and Blamey Road, then in a westerly direction along Blamey Road to the intersection of Blamey Road and Numurkah Road, then in a northerly direction along Numurkah Road to the intersection of Numurkah Road and Pinnucks Road, then in a westerly direction along Pinnucks Road to the intersection of Pinnucks Road and O'Briens Road, then in a northerly direction along O'Briens Road to the intersection of O'Briens Road and Reynoldsons Road, then in a westerly direction along Reynoldsons Road to the intersection of Reynoldsons Road and Rockliffs Road, then in a northerly direction along Rockliffs Road to the end of Rockliffs Road, then in a straight line in a north westerly direction until the straight line intersects with the Murray River, then in a north easterly direction along the Murray River, then in a south easterly direction along the Murray River to where Cemetery Road and the Murray River meet.

#### Schedule 2

The area of land within a radius of one and a half kilometres of the affected property at 35° 52.787 Northing, 145° 34.514 Easting.

# ORDER DECLARING A RESTRICTED AREA AT TONGALA FOR THE CONTROL OF QUEENSLAND FRUIT FLY

#### 1. Objective

The objective of this Order is to declare a restricted area for the control of Queensland fruit fly at Tongala and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

#### 2. Authorising provisions

This Order is made under Sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

#### 3. Definition

In this Order -

- (a) "Act" means the Plant Health and Plant Products Act 1995; and
- (b) "Queensland fruit fly" means the exotic pest Bactrocera tryoni (Froggart); and
- (c) "Regulations" mean the Plant Health and Plant Products Regulations 1996.

# 4. Restricted area for the control of Queensland fruit fly

#### Schedule 1

The area of land bounded by a line commencing at the northern end of Agnes Road, then in a straight line in a northerly direction to where the line intersects with the Goulburn River, then in a north westerly direction along the Goulburn River to where it meets the intersection of Yambuna Road and Glanville Road, then in a westerly direction along Glanville Road to the intersection of Glanville Road and Watson Road, then in a northerly direction along Watson Road to the intersection of Watson Road and Bangerang Road, then in a straight line in a south westerly direction to the intersection of Tehan Road and Mitchell Road, then in a westerly direction along Mitchell Road to the intersection of Mitchell Road and McDonald Road, then in a southerly direction along McDonald Road to the intersection of McDonald Road and Scott Road, then in a westerly direction along Scott Road to the intersection of Scott Road and Looker Road, then in a southerly direction along Looker Road to the intersection of Looker Road and Murray Valley Highway, then in a westerly direction along Murray Valley Highway to the intersection of Murray Valley Highway and Simmie Road, then in a southerly direction along Simmie Road to the intersection of Simmie Road and O'dea Road, then in a westerly direction along O'dea Road to the intersection of O'dea Road and Sanctuary Road, then in a southerly direction along Sanctuary Road to the intersection of Sanctuary Road and Craig Road, then in a south westerly direction along Craig Road to the intersection of Craig Road and Gibson Road, then in a southerly direction along Gibson Road to the intersection of Gibson Road and Graham Road, then in an easterly direction along Graham Road to the intersection of Graham Road and Doherty Road, then in a southerly direction along Doherty Road to the intersection of Doherty Road and Gray Road, then in an easterly direction along Gray Road to the intersection of Gray Road and Thornton Road, then in a southerly direction along Thornton Road to the intersection of Thornton Road and MacGregor Road, then in an easterly direction along MacGregor Road to the intersection of MacGregor Road and Tehan Road, then in a southerly direction along Tehan Road to the intersection of Tehan Road and Kyabram–Rochester Road, then in an easterly direction along Kyabram–Rochester Road to the intersection of Kyabram–Rochester Road and Fraser Road, then in a southerly direction along Fraser Road to the intersection of Fraser Road and Gillies Road, then in an easterly direction along Gillies Road to the intersection of Gillies Road and McEwen Road, then in a northerly direction along McEwen Road to the intersection of McEwen Road and Lilford Road, then in an easterly direction along Lilford Road to the intersection of Lilford Road and Coomacooma–Kyabram Road, then in a northerly direction along Coomacooma–Kyabram Road to the intersection of Coomacooma–Kyabram Road and Murrumba Road, then in a northerly direction along Murrumba Road to the intersection of Murrumba Road and Byrneside–Kyabram Road, then in an easterly direction along Byrneside–Kyabram Road to the intersection of Trevaskis Road, then in a northerly direction along Trevaskis Road to the intersection of Murray Valley Highway, then in a westerly direction to the intersection of Murray Valley Highway and Agnes Road, then in a northerly direction to the northern end of Agnes Road.

#### Schedule 2

The area of land within a radius of one and a half kilometres of the affected property at -36° 24.912 Northing, 144° 94.948 Easting.
