NOTICE OF DECISION Zoological Parks and Gardens Regulations 2003

I, John Thwaites, Minister for Environment and Minister responsible for the administration of the Zoological Parks and Gardens Act 1995, give notice under Section 12 of the Subordinate Legislation Act 1994, as follows:

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Zoological Parks and Gardens Regulations 2003 to –

- provide for fees payable for entry to zoological parks;
- provide for concessional charges for entry to zoological parks;
- provide for exemption from payment of fees or charges for entry to zoological parks for certain classes of person;
- make provision for the care protection and management of zoological parks and managed land;
- make provision for the care, protection and management of the zoological collections in zoological parks or on managed land.

The RIS was advertised seeking public comment and 6 submissions were received.

After considering these submissions, I have decided that the proposed Zoological Parks and Gardens Regulations 2003 should be made with amendments.

- 13. York on Lilydale Resort, York Road, Mount Evelyn.
