PROPOSED AMENDMENT TO LOCAL LAW 5

Amendment of Penalties for Breaches of Building Site Stormwater Code of Practice

Council proposes to amend its existing Local Law 5 (Environment and Amenity). The following information about the proposed amendment is provided in accordance with the Local Government Act 1989.

Purpose of the Proposed Amendment

The purpose of the amendment is to alter the on the spot infringement notice for breaches of Clauses 10(2) and 10(3) of the Local Law from 20 penalty units (\$2,000) to 10 penalty units (\$1,000). These penalties are for the offence of non-compliance with requirements imposed by the Building Site Stormwater Code of Practice (Clause 10(2)) and refusal to identify parties responsible for contravening the said Code (Clause 10(3)). The adjustment to the penalties will establish an appropriate correlation between the penalty able to be imposed by a court of law (20 penalty units) and an infringement notice (10 penalty units).

Purpose and General Purport of Local Law 5

Medical Practice Act 1994 NOTICE

Re: Dr David Tomas Andrews

A Panel of the Medical Practitioners Board of Victoria on 4 March 2003 conducted a Formal Hearing into the professional conduct of Dr David Tomas Andrews a registered medical practitioner.

The Panel found pursuant to Section 50(1)(a) of the **Medical Practice Act 1994** ("the Act") that Dr Andrews had engaged in unprofessional conduct of a serious nature.

Further, the Panel determined that:

 Dr Andrews is reprimanded under Section 50(2)(c) of the Medical Practice Act 1994 ("the Act") for dishonesty in respect of theft of prescription pads and the writing of forged prescriptions and under Section 50(2)(f) of the Act a fine of 20 penalty points (\$2,000) is imposed on each of these two matters, payable within 2 months.

- 2. In respect of his drug-taking behaviour, under Section 50(2)(e) of the Act the Panel imposes the following conditions on Dr Andrews' registration:
 - Dr Andrews is to attend the Victorian Doctors Health Program ("VDHP"), and adhere to arrangements made with the VDHP for follow-up and screening, for as long as the VDHP considers necessary;
 - Dr Andrews is to abstain from self-prescribing, Schedule 4 and Schedule 8 drugs;
 - Dr Andrews is to inform the Medical Practitioners Board of Victoria ("the Board") of the name of his treating doctor within 14 days. This is to facilitate the Board communicating with him for the purpose of obtaining reports at Dr Andrews' expense on Dr Andrews' fitness to practice at any time;
 - Dr Andrews is to inform the Board within 14 days of this date of the name/s of the hospital/s and of the Director/s of Anaesthetics of these hospital/s in which he is currently working and within 14 days of commencing to work at new locations until such time as the Deputy Chief Executive Officer indicates that he need not do so;
 - Dr Andrews is to facilitate the Board's obtaining reports from such hospitals and Directors of Anaesthetics at any time the Deputy Chief Executive Officer considers this necessary.

Consumer Affairs Victoria has undertaken a joint review of the fee structure for the four registration systems established under the **Business Names Act 1962, Associations Incorporation Act 1981, Co-operatives Act 1996** and Part 3 of the **Partnership Act 1958**. The purpose of this review is to ensure that the fees charged are commensurate with the costs of administration of these Acts.

The proposed Business Names Regulations 2003, Associations Incorporation (Fees) Regulations 2003, Co-operatives (Fees) Regulations 2003 and Partnership (Limited Partnerships) Regulations 2003 prescribe new fees for the purposes of the four Acts. The Business Names Regulations 2003 will also remake the current Business Names Regulations (No 2) 1992 which will sunset on 27 July 2003, and will prescribe particulars to be included in forms and statements lodged under the **Business Names Act 1962**.

The objectives of the proposed Regulations are to determine an appropriate licensing fee structure for the administration of the public registers established under the four Acts. An increasing number of lodgement transactions under the Acts will be able to be performed online, and the fee structures will reflect this new opportunity. The objectives of the Business Names Regulations also include the prescription of particulars to be included in the forms and statements to be lodged under the Act in order to ensure that the Business Names Register contains all the information necessary for its proper administration.

A Regulatory Impact Statement (RIS) has been prepared for the proposed Regulations. The RIS considers a draft of the four sets of Regulations and examines alternatives to them. The cost-benefit analysis in the RIS demonstrates that the benefits of the proposed Regulations outweigh the costs. It concludes that the objectives of the Acts are best achieved by the current form of the proposed regulations.
