# DECLARATION OF EXEMPTION FROM PART 3 OF THE HEALTH SERVICES ACT 1988

Rural Northwest Health Order in Council

The Governor in Council on the recommendation of the Minister for Health and pursuant to section 11(1) of the **Health Services**Act 1988 declares that the provisions of Part 3 of that Act as specified hereunder do not have effect in relation to the agency known as Rural Northwest Health.

Section 33(3), (4), (5), (6), (8) and (10) and section 36 with the exception of submitting the report of operations and financial statements prepared in accordance with Part 7 of the **Financial Management Act 1994**.

This Order comes into effect on the day it is published in the Government Gazette.

# 1. Appointment Arrangements

The appointment is part-time.

# 2. Period of Appointment

The appointment is until 30 June 2004.

## 3. Termination of Arrangements

Under Section 35(1) – written resignation addressed to the Governor in Council.

Under Section 35(2) – removal from the board by the Governor in Council.

#### 4. Payment Provisions

The member will be paid remuneration of \$30,000.00 per annum.

# 5. Superannuation Obligations

Superannuation contributions will be paid by the employer in accordance with the Commonwealth's **Superannuation** Guarantee Act 1992.

# 5. Travel and Personal Expenses Arrangements

Under Section 34(2) members are entitled to be paid expenses incurred in holding office as members of the board.

# 7. Leave Arrangements

There are no leave provisions for this part-time statutory position.
