Country Fire Authority Act 1958

VARIATION OF FIRE DANGER PERIOD

In pursuance of the powers conferred by Section 4 of the **Country Fire Authority Act 1958**, I, Neil Graeme Bibby, Chief Executive Officer of the Country Fire Authority, after consultation with the Secretary to the Department of Sustainability and Environment, hereby vary the declaration of the Fire Danger Periods previously published in the Government Gazette by declaring that such Fire Danger Periods shall end in respect of the undermentioned Municipal Districts of Municipalities or parts of Municipalities specified.

To terminate from 0100 hours 14 April 2003:

Pyrenees Shire (Part) that portion south and west of the line described as:— From the Shire boundary road, south east along Geelong Road, then east along Stockyard Hill–Wangatta Road, then south along Stockyard Hill Road to Carngham–Streatham Road. In an easterly direction, to Mount Emu Creek, then to follow the Mount Emu Creek to Murray Street, Skipton in a westerly direction to Beaufort–Skipton Road and then in a southerly direction along Alexander Road to the Shire boundary.

Shire of Strathbogie, City of Greater Shepparton, Shire of Moira.

To terminate from 0100 hours 28 April 2003:

Shire of Yarra Ranges, City of Manningham (that portion not included in the Metropolitan Fire District), City of Maroonah (that portion not included in the Metropolitan Fire District), Shire of Nillumbik (that portion not included in the Metropolitan Fire District), City of Banyule (that portion not included in the Metropolitan Fire District), City of Knox.
