NOTICE OF DECISION

Domestic (Feral and Nuisance) Animals (Amendment) Regulations 2003

I, Bob Cameron, Minister for Agriculture and Minister responsible for the administration of the **Domestic (Feral & Nuisance) Animals Act 1994**, give notice under section 12 of the **Subordinate Legislation Act 1994**, as follows:

A Regulatory Impact Statement (RIS) was prepared in relation to the proposed Domestic (Feral and Nuisance) Animals (Amendment) Regulations 2003 to amend the Domestic (Feral and Nuisance) Animals Regulations 1996 to:—

- amend the manner of permanent identification of animals; and
- prescribe requirements relating to the permanent identification of restricted breed dogs; and
- prescribe the requirements for enclosures for restricted breed dogs; and
- prescribe warning signs for restricted breed dogs; and
- prescribe the application fee for review of a decision to declare a dog a restricted breed dog; and
- make miscellaneous amendments to those Regulations.

The RIS was advertised seeking public comment and 48 submissions were received.

After considering these submissions, I have decided that the proposed Domestic (Feral and Nuisance) Animals (Amendment) Regulations 2003 should be made with amendments.
