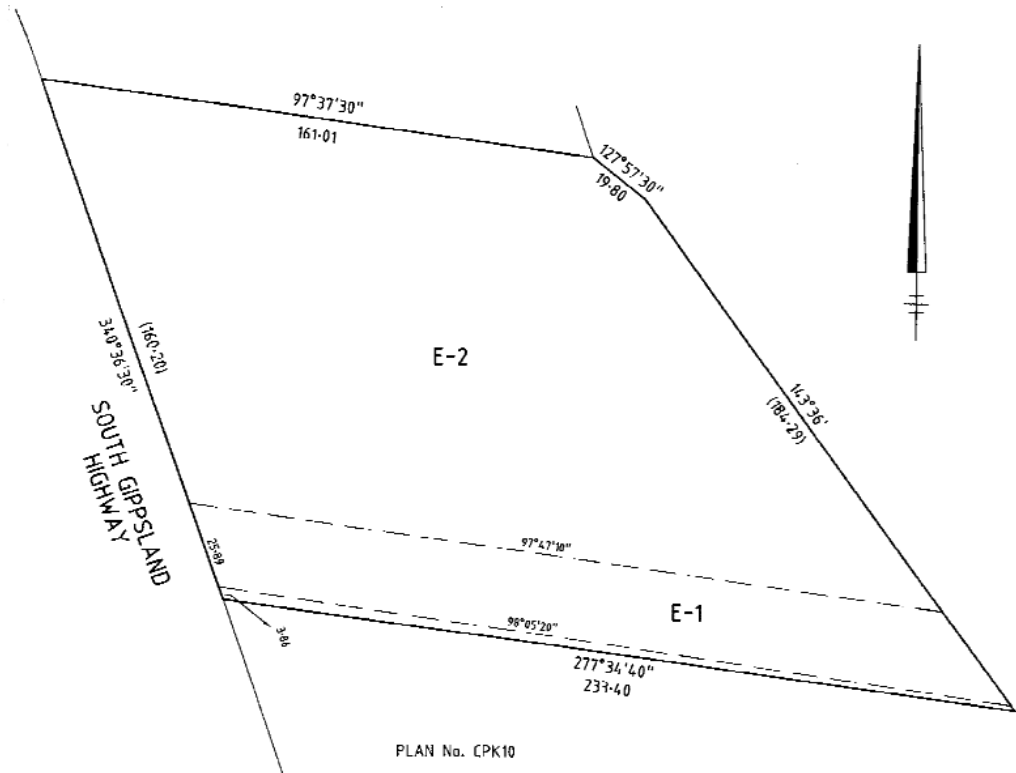

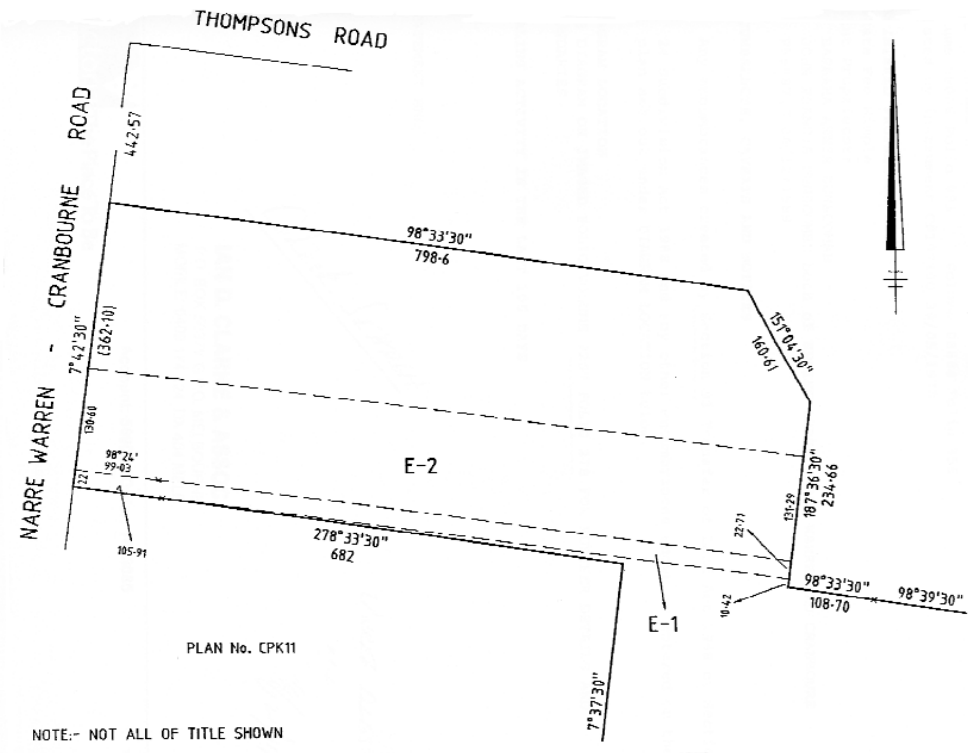
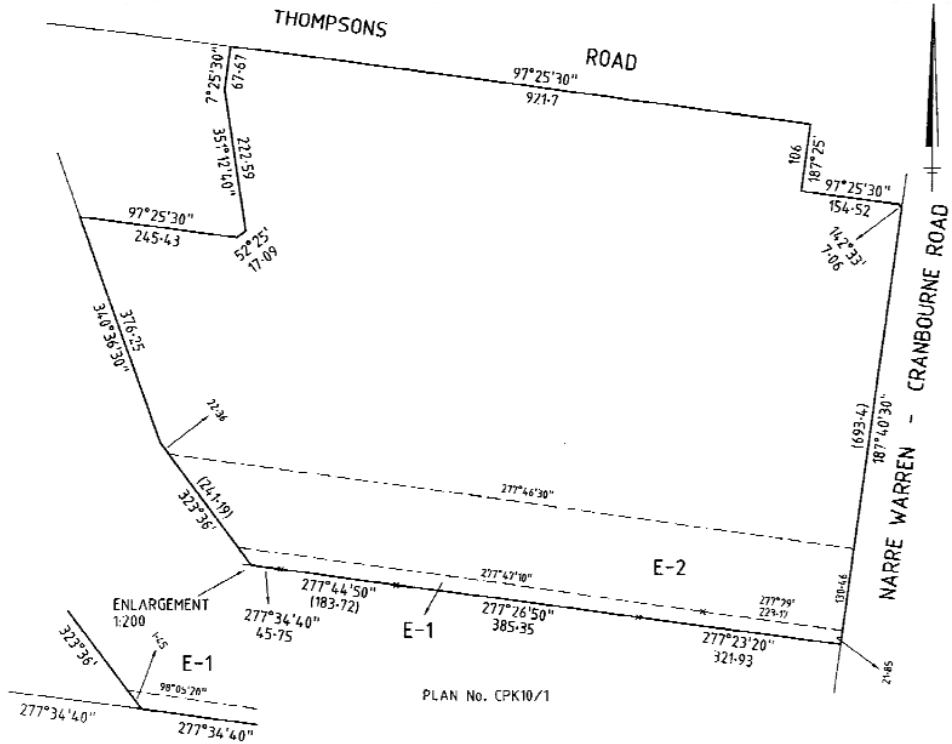
APPROVAL TO TXU ELECTRICITY LTD TO COMPULSORILY ACQUIRE EASEMENTS

Order in Council

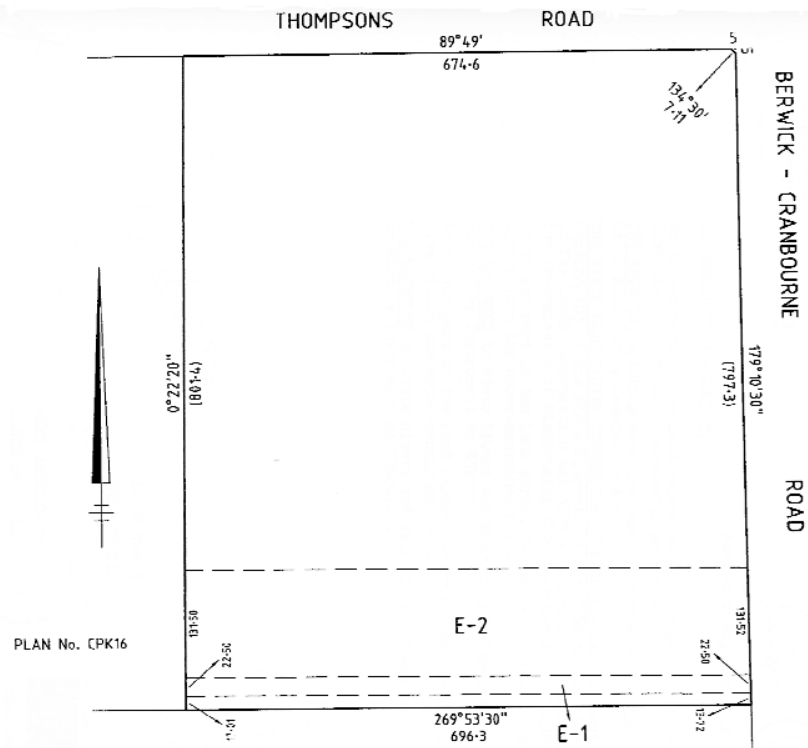
