WODONGA PLANNING SCHEME Notice of Approval of Amendment Amendment C16

The Minister for Planning has approved Amendment C16 to the Wodonga Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government

The Amendment rezones land required for the National Distribution Centre – Wodonga located at the junction of the Murray Valley Highway and Hume Freeway at Barnawartha North. Specifically the Amendment:

- rezones 394 hectares of land located on the north western corner of the interchange of the Murray Valley Highway and Hume Freeway from a Rural to an Industrial 1 Zone:
- includes the land proposed to be rezoned Industrial 1 within a Design and Development Overlay.
