DELETION OF SCHEDULE A

"A steel pipeline approximately 270 km in length with a nominal bore originating at the Iona gas plant near Port Campbell and connecting to the proposed Minerva gas plant just north of Port Campbell. The pipeline then traverses approximately 10 km to meet up with the existing GasNet Australia (Operations) Pty Ltd transmission pipeline and runs parallel to

the GasNet easement for approximately 40 km. The pipeline will then head northwest towards Casterton. From Casterton, the pipeline continues in a northwesterly direction crossing the South Australia–Victoria border east of Naracoote, as indicated on the attached endorsed Victorian Cadastral Plans Sheets 1–25 Revision 07, dated 18 February 2002.

ADDITION OF SCHEDULE A

"A steel pipeline approximately 270 km in length. A system of dual pipelines with an outside diameter of 457 mm and 355 mm respectively, originating at the Iona Gas Plant near Port Campbell and connecting to the proposed Minerva Gas Plant just north of Port Campbell. A single pipeline with an outside diameter of 457 mm then traverses approximately 10 km to meet up with the existing GasNet Australia (Operations) Pty Ltd transmission pipeline and runs parallel to the GasNet easement for approximately 40 km. The 457 mm diameter pipeline then continues to the Myakie future compressor station site, located approximately 10 kms northwest of Branxholme between Avery and Condah-Coleraine Roads. From this location, a dual pipeline with an outside diameter of 355 mm continues in a northwesterly direction past Casterton crossing the South Australia-Victoria border east of Naracoote, as indicated on the attached endorsed Victorian Casastral Plans Sheets 1 to 7 Revision 08, dated 10 September 2002, Sheet 8 Revision 07, dated 18 February 2002 and Sheets 9 to 25 Revision 08, dated 10 September 2002.
