VICTORIA PLANNING PROVISIONS
Notice of Approval of Amendment
Amendment VC18

The Minister for Planning has approved Amendment VC18 to the Victoria Planning Provisions.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment introduces core planning provisions for Melbourne metropolitan green wedge land in the Victoria Planning Provisions, the Brimbank Planning Scheme, Cardinia Planning Scheme, Casey Planning Scheme, Frankston Planning Scheme, Greater Dandenong Planning Scheme, Hobsons Bay Planning Scheme, Hume Planning Scheme, Kingston Planning Scheme, Knox Planning Scheme, Manningham Planning Scheme, Maroondah Planning Scheme, Melton Planning Scheme, Mornington Peninsula Planning Scheme, Nillumbik Planning Scheme, Whittlesea Planning Scheme, Wyndham Planning Scheme and Yarra Ranges Planning Scheme. The purpose of the new Particular provision, Clause 57, is:

- to protect metropolitan green wedge land from uses which would diminish its agricultural, environmental, conservation, landscape, natural resource or recreation values;
- to protect productive agricultural land from incompatible uses;
- to ensure that the scale of use is compatible with the non-urban character of metropolitan green wedge land;
- to encourage the location of urban activities in urban areas.
