MELBOURNE PLANNING SCHEME

Notice of Approval of Amendment Amendment C74

The Minister for Planning has approved Amendment C74 to the Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette

The Amendment includes the land at 191 Salmon Street and 600 Lorimer Street (north portion), Port Melbourne within a Business 3 Zone in Map No. 8, and replaces the Schedule to Clause 34.03 Business 3 Zone with a new Schedule.

The Minister has granted the following permit under Division 5, Part 4 of the Act:

Permit No. 2003/0140.

Description of land: 191 Salmon Street, Port Melbourne.
