## **Transport Act 1983**

### **ROAD DECLARATIONS AND DEDICATIONS AND DISCONTINUANCE OF ROADS OR PARTS OF ROADS**

#### **Road Declarations and Dedications –**

The Roads Corporation pursuant to the **Transport Act 1983**, upon publication of this notice declares and rescinds the roads, as described in Schedule A and on the plans attached.

#### **Discontinuance of Roads or Parts of Roads –**

The Roads Corporation, in pursuance of the powers conferred by Clause 2, Schedule 4 of the **Transport Act 1983**, hereby approves the discontinuance of the roads or parts of the roads as described in Schedule B and on the plan attached, and approves the sale of the surplus land as provided in Section 47 of the **Transport Act 1983** and as delegated by the Minister for Transport under Section 32 of the said Act.

### **SCHEDULE A**

#### **STATE HIGHWAY**

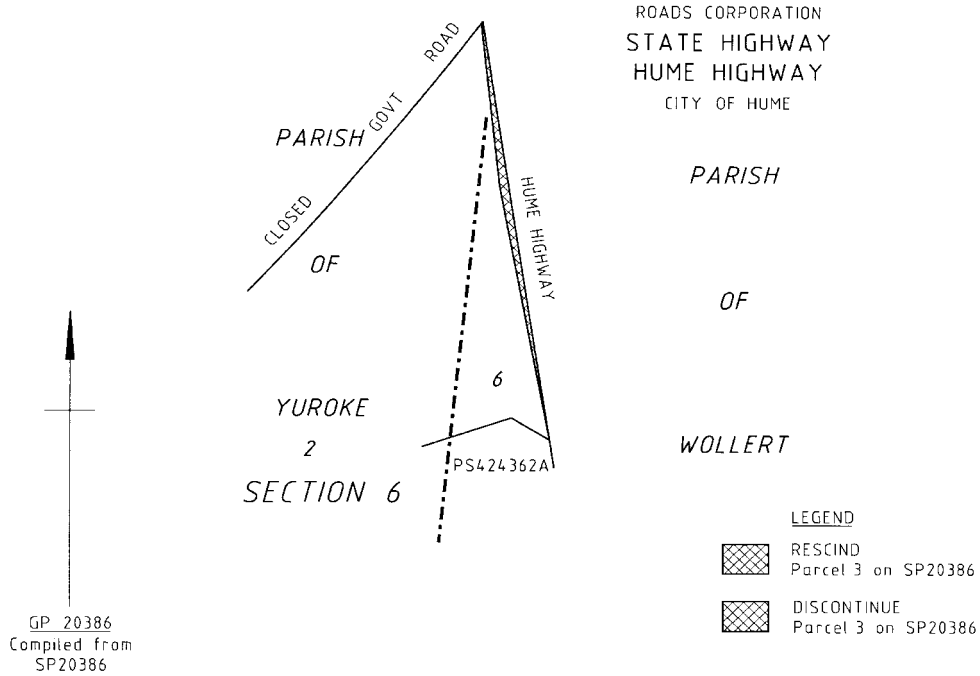
- a) Those parts of the Hume Highway in the City of Hume identified by hatching on the plan numbered GP 20386. The road or parts of the road are rescinded as described in the Legend on the said plan.

#### **MAIN ROAD**

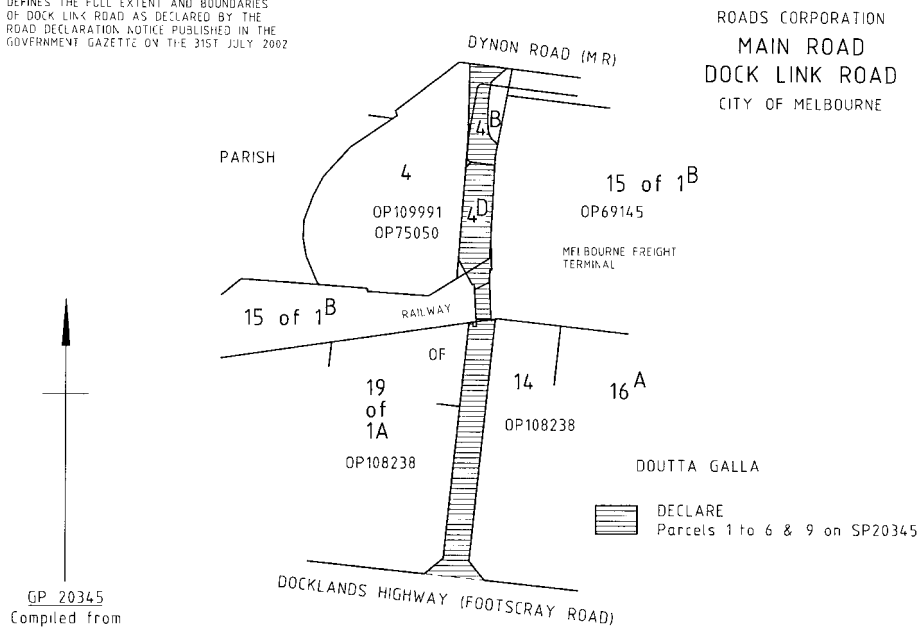
- b) Those parts of Dock Link Road in the City of Melbourne identified by hatching on the plan numbered GP 20345. The road or parts of the road are declared as described in the Legend on the said plan.

### **SCHEDULE B**

- a) The land in the City of Hume described as Hume Highway in the Parishes of Wollert and Yuroke, referred to on the plan numbered GP 20386. The road or parts of the road described in the Legend on the said plan are discontinued.
