Marine Safety Victoria, on the recommendation of Parks Victoria, hereby gives notice under subsection 15(1) of the **Marine Act 1988** that for the periods 11.00 am to 5.00 pm on the 5 July 2003, and 1.00 pm to 6.45 pm on the 6 July 2003,

- (a) the operation of vessels on the Yarra River, excluding those vessels listed in Table 1 below, involved with the BIA Melbourne Boat Show water ski demonstration event, is prohibited within an area extending from the upstream side of Spencer Street Bridge to a line of buoys extending across the river from the upstream side of the Helicopter's Victoria floating helipad on the northern bank to the upstream side of Dukes Dock on the southern bank.
- (b) vessels involved with the BIA Melbourne Boat Show water ski demonstration event listed in this Notice are exempted from Clauses 2(c), 3(a), 3(b), 7(1) and 19(b) of Notice No.1 made under section 15(2) of the **Marine Act 1988** for the time periods detailed above.
