COMMONWEALTH GAMES PROJECT ORDER

Games Village project

In accordance with section 15 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), and as Minister administering the Act, I declare the following project to be a Commonwealth Games project to which the Act applies:

The "Games Village project", as defined in the Act;

AND I authorise the development of that project for the period commencing on the date of publication of this Order until its completion;

AND in accordance with section 17 of the Act I specify the Secretary, as defined in the Act, to be responsible for the project to which this Order applies;

AND in accordance with section 26 of the Act I specify that the Secretary, as defined in the Act, is to be responsible for managing or developing the project.

This Order shall take effect from the date of its publication in the Government Gazette.
