Under and for the purposes of Item 1 of Schedule 3 to the WorkCover Insurance Premiums Order (No.10) 2002/2003, the Victorian WorkCover Authority has determined that the values of  $F_0^c$ ,  $F_1^c$  and  $F_2^c$ , for the purposes of calculating the Experience Factor E, for a period of coverage of a workplace, are respectively the relevant numbers specified in the following Table, opposite the authorised agent which calculated the costs of claims of the workplace:
