## ERRATUM NOTICE

### Accident Compensation (WorkCover Insurance) Act 1993

#### WORKCOVER INSURANCE PREMIUMS ORDER (No. 11) 2003/2004

This erratum notice corrects an error in the notice under the above heading published in the Victoria Government Gazette No. S 161 on 4 September 2003. The Table in that notice showed the value of  $F_3$  for the authorised agent, Cambridge Integrated Services Victoria Pty Ltd, as 2.055047. This number was incorrect and should have been shown as 3.055047. All other numbers published in that notice are correct.

Under and for the purposes of Item 1 of Schedule 3 to the WorkCover Insurance Premiums Order (No. 11) 2003/2004, the Victorian WorkCover Authority has determined that the value of  $F_3$ , for the purposes of calculating the Experience Factor E, for a period of coverage of a workplace, for Cambridge Integrated Services Victoria Pty Ltd, is 3.055047.
