### DECLARATION OF VEHICLES FOR THE PURPOSES OF THE DEFINITION OF RESTRICTED HIRE VEHICLE UNDER SECTION 86 OF THE TRANSPORT ACT 1983

I, Peter Batchelor MP, Minister for Transport, declare by this notice all commercial passenger vehicles with a seating capacity for not more than 12 people including the driver and which are more than 25 years old, calculated from the date of manufacture of the vehicle, to be a category of vehicle to which paragraph (c) within the definition of "restricted hire vehicle" under section 86 of the **Transport Act 1983** applies.
