Building Act 1993

DEFINITION OF DESIGNATED INSURER.

Acceptable credit rating as of 1 January 2004

Under section 137AA(6) of the **Building Act 1993** the acceptable international credit rating for insurance for domestic building work is declared as a rating provided by a specified agency and a rating that is equal to or exceeds the specified rating. Under section 137AA(8) of the **Building Act 1993**, I John Thwaites, have consulted with the Minister administering the **Victorian Managed Insurance Authority Act 1996** and pursuant to section 137AA(6) I hereby specify the agency names in column 1 to be the credit rating agencies for the purpose of section 137AA(6)(a) and the rating listed in column 3 to be the rating in relation to that agency as specified in section 137AA(b). From 1 January 2004 all insurers of domestic building work in category 137AA(2)(c) will be required to meet at least one of the minimum ratings.
