Sale of Land Regulations 2004

A Regulatory Impact Statement for the proposed Sale of Land Regulations 2004 was advertised for public comment on 25 November 2003 and a number of submissions were received.

Following consideration of the submissions, I now give notice of my intention to recommend that the proposed Regulations be made.

The following changes have been made to the proposed Sale of Land Regulations 2004:

- minor technical amendments; and
- proposed Regulation 6(2)(a) has been deleted because it duplicates one of the requirements of the Sale of Land Act 1962 (as amended by the Estate Agents and Sale of Land Acts (Amendment) Act 2003) in relation to permissible vendor bids, being the requirement that the auctioneer orally declare, before the bidding starts, that the auction conditions permit the making of vendor bids.
