### VICTORIA PLANNING PROVISIONS

#### Notice of Approval of Amendment

#### Amendment VC28

The Minister for Planning has approved Amendment VC28 to the Victoria Planning Provisions and all planning schemes in Victoria, except the Port of Melbourne Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment introduces a new Particular provision, Clause 52.34 Bicycle facilities, and establishes the Australian Standard for bicycle parking facilities as an incorporated document in all planning schemes.
