### Water Industry Act 1994

### NOTICE OF WATER CUSTOMER SERVICE CODE

The Essential Services Commission ("Commission") gives notice under section 4F(4) of the **Water Industry Act 1994** (Vic) ("Act") that it has, pursuant to section 4F(1) of the Act and in accordance with clause 15 of the Water Industry Regulatory Order 2003, made a Customer Service Code ("Code") specifying standards and conditions of service and supply that Victorian metropolitan and regional water businesses must comply with in providing regulated services to urban customers.

The Code applies in respect of water businesses' basic water supply services intended for drinking water, reticulated non-potable water, recycled water services (unless specifically exempted by the Code or by a decision of the Commission) and sewerage services.

The Code applies to water businesses from 1 July 2005, except for Part A (Separate Written Agreements) and Part C (Customer Charters) which take effect on and from 1 November 2004.

#### Definitions

"Metropolitan water business" means City West Water Limited (ACN 066 902 467), South East Water Limited (ACN 066 902 547), Yarra Valley Water Limited (ACN 066 902 501) and their successors.

"Non-potable water" means water that is the subject of a declaration made by the Minister under section 6 of the **Safe Drinking Water Act 2003**, known under that Act as 'regulated water'.

"Regional water business" means a regional urban water authority constituted under the **Water Act** 1989 or its successor.
