No. 79/2004 **Major Crime (Investigative Powers) Act 2004**

No. 80/2004 **Pharmacy Practice Act 2004**

No. 81/2004 **Planning and Environment (General Amendment) Act 2004**

No. 82/2004 **State Concessions Act 2004**

No. 83/2004 **Teaching Services (Conduct and Performance) Act 2004**

No. 79/2004 (1) Subject to this section, this Act (except sections 75, 97 and 130) comes into operation on a day or days to be proclaimed.

(2) Sections 75 and 97 come into operation on the day on which this Act receives the Royal Assent.

(3) Section 130 is deemed to have come into operation on the day on which the **Major Crime Legislation (Office of Police Integrity) Act 2004** received the Royal Assent.

(4) If a provision of this Act, other than sections 75, 97 or 130, does not come into operation before 1 July 2005, it comes into operation on that day.

No. 80/2004 (1) Sections 1, 140, 147, 148 and this section come into

operation on the day on which this Act receives the Royal Assent.

(2) Subject to sub-section (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.

(3) If a provision referred to in sub-section (2) does not come into operation before 1 July 2005, it comes into operation on that day.

No. 81/2004 (1) Subject to sub-section (2), this Act comes into operation on a day or days to be proclaimed.

(2) If a provision of this Act does not come into operation before 1 January 2006, it comes into operation on that day.

No. 82/2004 (1) Subject to sub-section (2), this Act comes into operation on a day to be proclaimed.

(2) If this Act does not come into operation before 1 March 2005, it comes into operation on that day.

No. 83/2004 (1) This Act, except sections 11 and 12, comes into operation on 1 January 2005.

(2) Sections 11 and 12 come into operation on the day after the day on which this Act receives the Royal Assent.
