**Crown Land (Reserves) Act 1978**

CROWN LAND (RESERVES)  
(NATURE CONSERVATION RESERVE) REGULATIONS 2004

**PART 1—PRELIMINARY**

**1. Title**

These Regulations may be cited as the Crown Land (Reserves) (Nature Conservation Reserve) Regulations 2004.

**2. Objectives**

The objectives of these Regulations are to provide for—

- (a) the care, protection and management of nature conservation reserves; and
- (b) the preservation of good order in nature conservation reserves; and
- (c) the conditions under which any services or facilities may be used in nature conservation reserves; and
- (d) the safety of persons in nature conservation reserves or any part of those reserves; and
- (e) the issuing of permits in relation to activities in nature conservation reserves.

**3. Authorising provision**

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

**4. Commencement**

These Regulations come into operation on the day on which they are published in the Government Gazette.

**5. Expiry**

These Regulations expire on the day that is 10 years after the day on which they come into operation.

**6. Revocation**

All previous regulations made under section 13 of the **Crown Land (Reserves) Act 1978** or any corresponding provision of the **Land Act 1958**, insofar as they apply to any nature conservation reserve referred to in these Regulations, are revoked.

**7. Definitions**

In these Regulations—

“**aircraft**” includes an aeroplane, helicopter, glider, hot air balloon, hang glider, paraglider and parachute;

“**animal**” means any animal except any human or fish, whether vertebrate or invertebrate, in any stage of biological development and whether alive or dead;

“**camp**” means—

- (a) to erect, occupy or use for accommodation purposes a tent or any similar form of shelter including a swag or sleeping bag; or
- (b) to occupy or use for accommodation purposes a vehicle or other moveable form of accommodation;

“**contractor**” includes any sub-contractor or employee of a contractor or sub-contractor;

“**fauna**” means any animal or part of an animal that is indigenous to Victoria;

“**fire**” includes a barbecue that uses solid, liquid or gaseous fuel;

“**firearm**” has the same meaning as in the **Firearms Act 1996**;

“**firewood**” means dead plant material not attached to a standing plant including a shrub or tree;

“**fish**” has the same meaning as in the **Fisheries Act 1995**;

“**flora**” means a plant indigenous to Victoria or part of such a plant in any stage of biological development, whether the plant or part of the plant is vascular or non-vascular and whether alive or dead;

“**indigenous fish**” includes any kind or species of fish indigenous to Victoria;

“**nature conservation reserve**” means—

- (a) the Gurdies Nature Conservation Reserve, being Allotment 97F, Parish of Corinella, permanently reserved for the Conservation of Native Plants and Animals under the **Crown Land (Reserves) Act 1978** by Order in Council dated 26 May 1992, published in the Government Gazette of 3 June 1992, page 1384;
- (b) any other reserve listed in the Schedule to which these Regulations are extended and applied by regulation 8;

“**Parks Victoria**” means the body established under Part 2 of the **Parks Victoria Act 1998**;

“**powered vessel**” means a vessel that has an engine that is used or is capable of being used for propulsion;

“**public fireplace**” means a fireplace provided by Parks Victoria for the general use of visitors to a nature conservation reserve;

“**Secretary**” means the body corporate established by Part 2 of the **Conservation, Forests and Lands Act 1987**;

“**the Act**” means the **Crown Land (Reserves) Act 1978**;

“**vehicle**” has the same meaning as in the **Road Safety Act 1986**;

“**vessel**” has the same meaning as in the **Marine Act 1988**.

#### 8. **Extension and application of these Regulations to reserves listed in the Schedule**

For the purposes of section 13(1)(b)(xii) of the **Crown Land (Reserves) Act 1978**, these Regulations are extended to and apply to the reserves listed in the Schedule.

#### 9. **Application of certain regulations**

- (1) These Regulations do not apply to any of the following persons when acting in the course of that person’s duties—
  - (a) a member of the police force; or
  - (b) an authorised officer; or
  - (c) a person employed under Part 3 of the **Public Sector Management and Employment Act 1998** or an employee of Parks Victoria; or
  - (d) a contractor, volunteer or other person carrying out any work for or acting on the authority or instruction of the Secretary or Parks Victoria; or
  - (e) a person dealing with a fire, flood or other emergency.
- (2) A person acting in accordance with a lease, licence, tenancy, permit or authority granted or issued under the Act, or an agreement entered into under the Act, or an Act relating to a nature conservation reserve, is not subject to these Regulations, to the extent that the activities authorised by that lease, licence, tenancy, permit, authority or agreement are inconsistent with these Regulations.

**PART 2—AREAS SET ASIDE IN NATURE CONSERVATION RESERVES****10. Areas where access is prohibited**

- (1) The Minister may determine that access is prohibited to an area in a nature conservation reserve set aside for—
  - (a) the protection or management of flora and fauna, or geological, geomorphological, archaeological, cultural or historic features or values; or
  - (b) the planting of trees, shrubs, grass or other vegetation; or
  - (c) the re-establishment of vegetation; or
  - (d) the reclamation of land; or
  - (e) the protection of buildings, facilities or other assets; or
  - (f) reasons of public safety.
- (2) The Minister—
  - (a) may determine the periods during which access is prohibited to areas set aside under sub-regulation (1); and
  - (b) must cause signs or notices to be erected or displayed indicating the areas set aside under sub-regulation (1) to which access is prohibited and the purpose for which the area is set aside.
- (3) A person must not enter an area in a nature conservation reserve set aside under sub-regulation (1) to which access is prohibited and for which a sign or notice has been erected or displayed in accordance with sub-regulation (2)(b).

**11. Areas where vehicles are prohibited**

- (1) The Minister may determine that entry by vehicles generally or by vehicles of a particular class is prohibited to an area in a nature conservation reserve set aside to prevent access by vehicles generally or by vehicles of a particular class.
- (2) The Minister—
  - (a) may determine the periods during which access to vehicles generally or vehicles of a particular class is prohibited to areas set aside under sub-regulation (1); and
  - (b) must cause signs or notices to be erected or displayed indicating the areas set aside under sub-regulation (1) to which access by vehicles generally or vehicles of a particular class is prohibited and the purpose for which access is prohibited.
- (3) A person must not drive or cause a vehicle to enter an area in a nature conservation reserve set aside under sub-regulation (1) to which access is prohibited to vehicles generally and for which a sign or notice has been erected or displayed in accordance with sub-regulation (2)(b).
- (4) A person must not drive or cause a vehicle of a particular class to enter an area in a nature conservation reserve set aside under sub-regulation (1) to which access is prohibited to vehicles of that class and for which a sign or notice has been erected or displayed in accordance with sub-regulation (2)(b).

**12. Areas for particular purposes**

- (1) The Minister may determine that a specified area in a nature conservation reserve be set aside for one or more of the following purposes—
  - (a) launching, landing, loading, unloading, mooring, anchoring or operation of powered vessels generally or powered vessels of a particular class; or
  - (b) camping; or
  - (c) bringing a dog under a person's care and control; or

- (d) riding, driving or leading horses; or
  - (e) protecting indigenous fish.
- (2) The Minister—
- (a) may determine the periods during which areas set aside under sub-regulation (1) may be used for the purpose for which they are set aside; and
  - (b) must cause signs or notices to be erected or displayed indicating the areas set aside under sub-regulation (1) and the purposes for which they are set aside.

### **PART 3—GENERAL CONTROL OF NATURE CONSERVATION RESERVES**

#### **13. Interfering with animals**

- (1) A person must not, in a nature conservation reserve—
- (a) disturb, harass, remove, hunt, capture, take, kill or injure or otherwise destroy or interfere with any fauna or other animal; or
  - (b) destroy, disturb or interfere with the nest, bower, display mound, lair or burrow of any fauna or other animal.
- (2) Sub-regulation (1) does not apply to a person who—
- (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.
- (3) A person must not, in a nature conservation reserve, feed, offer food or offer any object as food to any fauna or other animal, where the animal is not lawfully brought into the nature conservation reserve.

#### **14. Protecting vegetation**

- (1) A person must not, in a nature conservation reserve, cut, fell, pick, remove, take, destroy or damage any flora or other vegetation, whether alive or dead.
- (2) Sub-regulation (1) does not apply to a person who—
- (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

#### **15. Introducing vegetation**

- (1) A person must not, in a nature conservation reserve, knowingly bring in, plant or introduce any seed, tree, shrub, fern, algae or other vegetation, or any part of any tree, shrub, fern, algae or other vegetation.
- (2) Sub-regulation (1) does not apply to a person who brings firewood into a nature conservation reserve for the purposes of lighting or maintaining a fire in accordance with regulation 27(2)(a).

#### **16. Interfering with rocks, natural objects or features**

- (1) A person must not, in a nature conservation reserve, intentionally damage, deface, remove or otherwise interfere with any rock, or similar natural object, or geomorphological feature.
- (2) Sub-regulation (1) does not apply to a person who—
- (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**17. Digging or removal of material**

- (1) A person must not—
  - (a) dig or remove from a nature conservation reserve any gravel, shell, grit, sand, soil, rock or other similar material; or
  - (b) knowingly take into a nature conservation reserve any gravel, shell, grit, sand, soil, rock or other similar material.
- (2) Sub-regulation (1)(a) does not apply to a person who digs to bury faeces in a manner that complies with regulation 25.
- (3) Sub-regulation (1)(a) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**18. Signs and structures**

- (1) A person must not, in a nature conservation reserve—
  - (a) remove, cut, displace, deface or interfere with any sign or structure; or
  - (b) erect, construct or place any sign or structure.
- (2) Sub-regulation (1)(b) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1)(b); and
  - (b) is acting in accordance with the permit.

**19. Gates**

A person must not leave any gate in a nature conservation reserve open unless the gate is already open.

**20. Bicycles**

A person who rides or takes a bicycle into a nature conservation reserve must remain on roads or vehicular tracks.

**21. Powered vessels**

A person must not launch, land, load, unload, moor, anchor or operate a powered vessel in a nature conservation reserve other than in an area set aside under regulation 12(1) for the launching, landing, loading, unloading, mooring, anchoring or operation of—

- (a) powered vessels generally; or
- (b) powered vessels of a particular class where the area has been set aside in respect of a powered vessel of that particular class.

**22. Aircraft**

- (1) A person must not, in a nature conservation reserve—
  - (a) launch or land any aircraft; or
  - (b) deliver anything by an aircraft.
- (2) Sub-regulation (1) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**23. Camping**

- (1) A person must not camp in a nature conservation reserve other than in an area set aside under regulation 12(1) for the purpose of camping.

- (2) A person who camps in a nature conservation reserve in an area set aside under regulation 12(1) for the purpose of camping must—
- (a) camp more than 20 metres from any river, stream, well, spring, creek, dam, bore or watercourse; and
  - (b) maintain the area in a clean and tidy condition; and
  - (c) before vacating the site occupied, clear all litter and personal equipment from the site.

**24. Use of soap or detergent**

- (1) A person who uses any soap, detergent or similar substance in a nature conservation reserve must dispose of that substance—
- (a) at least 50 metres away from any river, stream, well, spring, creek, dam, bore or watercourse; and
  - (b) at least 50 metres landward of the high water mark.

**25. Hygiene**

If toilet facilities are not provided in a nature conservation reserve or if toilet facilities are not readily accessible in an area of the reserve, a person in a nature conservation reserve must bury his or her faeces more than 100 metres from any river, stream, creek, well, spring, dam, bore or watercourse.

**26. Use of toilets and other facilities**

- (1) A person must not, in a nature conservation reserve, enter or use a toilet or other facility designated for the use of persons of the opposite sex.
- (2) Sub-regulation (1) does not apply to the entering or use of a toilet or other facility by—
- (a) a child when accompanied by an adult; or
  - (b) a disabled person when accompanied by a carer; or
  - (c) a carer of a disabled person whilst caring for that person.

**27. Lighting or maintaining fires**

- (1) A person must not light or maintain a fire in the open air in a nature conservation reserve.
- (2) Sub-regulation (1) does not apply to a person who lights or maintains a fire in a nature conservation reserve at a time and during a period when the lighting of fires in that nature conservation reserve is not prohibited under any Act and the person does so—
- (a) in a public fireplace; or
  - (b) in a commercial appliance using liquid or gaseous fuel.
- (3) A person who lights or maintains a fire in accordance with sub-regulation (2) must ensure that the ground and airspace within a distance of 3 metres of the fire are clear of flammable material and, if the fire is in a commercial appliance, that—
- (a) the fuel used in the appliance is of a type that the appliance has been designed and manufactured to use; and
  - (b) the fire is contained in the appliance; and
  - (c) when the fire is alight, the appliance is placed in a stable position.
- (4) A person who has lit or maintained a fire in a nature conservation reserve must completely extinguish that fire—
- (a) immediately at the request of an authorised officer or member of the police force; or
  - (b) before leaving the place of the fire.



**28. Annoying equipment**

- (1) A person must not, in a nature conservation reserve—
  - (a) operate any generator, air-compressor, chainsaw or other noise producing equipment; or
  - (b) play any radio, stereo or other broadcasting equipment; or
  - (c) use any amplifier, public address system, loud hailer or similar device—likely to cause inconvenience or nuisance to any person.
- (2) Sub-regulation (1) does not apply to a person who uses the equipment for necessary medical purposes.
- (3) Sub-regulation (1) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**29. Dogs**

- (1) A person must not bring a dog into a nature conservation reserve or allow a dog to enter or to remain in the reserve.
- (2) Sub-regulation (1) does not apply to a disabled person who brings a dog into a nature conservation reserve to assist that person with respect to that person's disability.
- (3) Sub-regulation (1) does not apply to a person who—
  - (a) brings a dog under their care and control into a nature conservation reserve in an area set aside under regulation 12(1) for that purpose; and
  - (b) keeps the dog on a leash, chain or cord.
- (4) Sub-regulation (1) does not apply to a person who confines the dog in a vehicle, which is in transit through a nature conservation reserve, by a route that is usually open to the public for that purpose.
- (5) A person in charge of a dog in a nature conservation reserve in accordance with sub-regulation (2) or (3) must take reasonable steps to ensure that the dog's excrement does not remain in a nature conservation reserve.

**30. Horses**

- (1) A person must not ride, drive or lead a horse into a nature conservation reserve or allow a horse to enter or remain in a nature conservation reserve other than in an area set aside under regulation 12(1) for that purpose.
- (2) Sub-regulation (1) does not apply to a person who confines a horse in a vehicle which is in transit through a nature conservation reserve by a route that is usually open to the public for that purpose.

**31. Other animals**

- (1) A person must not bring an animal, other than a dog or horse in accordance with regulations 29 and 30, into a nature conservation reserve or allow any such animal under that person's care and control to enter or remain in a nature conservation reserve.
- (2) A person must not allow an animal in his or her care and control to stray or wander into a reserve.
- (3) Sub-regulation (1) does not apply to—
  - (a) a disabled person who brings an animal into a nature conservation reserve to assist that person with respect to that person's disability; or
  - (b) a person who brings bait into a nature conservation reserve for fishing purposes in an area where fishing is permitted.

**32. Fishing**

A person must not fish or attempt to take fish from any part of a nature conservation reserve set aside under regulation 12(1) for protecting indigenous fish.

**33. Firearms and weapons**

- (1) A person must not, in a nature conservation reserve, possess, carry or use any firearm, bow, cross-bow, spear gun, spear or similar weapon.
- (2) Sub-regulation (1) does not apply to a person who keeps the firearm or other weapon unloaded and concealed while being carried in a vehicle, which is in transit through a nature conservation reserve, by a route that is usually open to the public for that purpose.

**34. Traps and poisons**

- (1) A person must not, in a nature conservation reserve, possess, carry or use any trap, snare, net or poison.
- (2) Sub-regulation (1) does not apply to a person who possesses, carries or uses a dip net, landing net or gaff in an area other than an area set aside under regulation 12(1) for the protection of indigenous fish.
- (3) Sub-regulation (1) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**35. Research**

- (1) A person must not, in a nature conservation reserve, conduct any formal scientific research or organised educational activities.
- (2) Sub-regulation (1) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**36. Special events**

- (1) A person must not, in a nature conservation reserve, conduct any sporting, recreational or entertainment event or other organised function.
- (2) Sub-regulation (1) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**37. Commercial activities**

- (1) A person must not, in a nature conservation reserve—
  - (a) conduct a commercial activity or offer for sale or hire any article or service; or
  - (b) distribute or display any hand bill, pamphlet or advertising matter or put up or leave any advertising placard or notice; or
  - (c) take any photograph, film, video or audio recording for commercial purposes.
- (2) Sub-regulation (1) does not apply to a person who—
  - (a) holds a permit issued under regulation 38 to engage in an activity referred to in sub-regulation (1); and
  - (b) is acting in accordance with the permit.

**38. Permits**

- (1) The Minister may issue a permit for the activities referred to in regulations 22, 35, 36 and 37.
- (2) A permit issued for the activities in regulations 22, 35, 36 or 37 may, for that purpose, also permit activities referred to in regulations 13, 14, 16, 17, 18, 28 and 34.
- (3) A permit issued under sub-regulation (1) authorises the holder to enter and use a nature conservation reserve—
  - (a) for the purpose specified in the permit; and
  - (b) for the period specified in the permit; and
  - (c) subject to any terms and conditions in respect of that entry or use determined by the Minister and specified in the permit.
- (4) A permit issued by the Minister under these Regulations must be in writing.
- (5) The holder of a permit must comply with any terms and conditions of that permit.
- (6) The Minister may cancel a permit at any time—
  - (a) if the holder of the permit has breached the conditions of the permit or breached these Regulations; or
  - (b) if the continuation of the permit is likely to be detrimental to, or interfere with the management and protection of the natural environment, features, or visitors in a nature conservation reserve.
- (7) Upon cancellation of a permit under sub-regulation (5), the Minister must cause the holder of the permit to be notified in writing of the cancellation of the permit within a reasonable time after the cancellation.

**39. Directions by authorised officers**

An authorised officer may—

- (a) request any person whom that officer believes on reasonable grounds has contravened these Regulations to leave a nature conservation reserve or any part of a nature conservation reserve; or
- (b) request any person for the reason of public safety to leave a nature conservation reserve or any part of a nature conservation reserve.

**SCHEDULE****Alex Chisholm Nature Conservation Reserve**

Allotment 21 of Section 1A, Parish of Maryborough, temporarily reserved for the Preservation of Species of Native Plants under the **Land Act 1958** by Order In Council dated 8 August 1978, published in the Government Gazette of 16 August 1978, page 2713, and deemed under section 4(4) of the **Crown Land (Reserves) Act 1978** to be temporarily reserved under section 4(1) of that Act.

**Angels Rest Flora Reserve**

Allotment 4A, Parish of Kaneira, temporarily reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 28 August 1984, published in the Government Gazette of 5 September 1984, page 3083.

**Angliss Grassland (Laverton North) Nature Conservation Reserve**

Allotment 4A of Section 23, Parish of Truganina, deemed to be temporarily reserved for the Conservation of an Area of Natural Interest under section 5(7) of the **Crown Land (Reserves) Act 1978** on 26 July 1999.

**Bald Hill Nature Conservation Reserve**

Allotment 10A of Section 19, Parish of Kangerong, permanently reserved for the Conservation of an Area of Natural Interest under the **Crown Land (Reserves) Act 1978** by Order In Council dated 17 February 1987, published in the Government Gazette of 25 February 1987, page 425; and Allotment 20E, Parish of Kangerong, temporarily reserved for the Preservation of an Area of Ecological Significance under the **Crown Land (Reserves) Act 1978** by Order In Council dated 7 February 1989, published in the Government Gazette of 15 February 1989, page 356.

**Balmattum Nature Conservation Reserve**

Allotment 80A, Parish of Balmattum, deemed to be temporarily reserved for the Conservation of an Area of Natural Interest under section 5(7) of the **Crown Land (Reserves) Act 1978** on 8 February 2001.

**Balmoral Nature Conservation Reserve**

Allotment 6 of Section 13, Parish of Balmoral, Township of Balmoral, temporarily reserved as a Site for Public Purposes (Preservation of Flora and Fauna) under the **Land Act 1958** by Order In Council dated 3 December 1974, published in the Government Gazette of 11 December 1974, page 4261, and deemed under section 4(4) of the **Crown Land (Reserves) Act 1978** to be temporarily reserved under section 4(1) of that Act.

**Baluk Willam Nature Conservation Reserve**

Allotments 43K2 and 43L, Parish of Narree Worrان, deemed to be temporarily reserved for the Preservation of Species of Native Plants under Section 5(7) of the **Crown Land (Reserves) Act 1978** on 3 June 1987; and Allotments 43K1, 43K3 and 43L1, Parish of Narree Worrان, temporarily reserved for Public Purposes (Preservation of Species of Native Plants) under the **Crown Land (Reserves) Act 1978** by Order In Council dated 16 December 1997, published in the Government Gazette of 18 December 1997, page 3761.

**Banchory Grove Nature Conservation Reserve**

Allotment 1A of Section 26, Parish of Maribyrnong, temporarily reserved for the Conservation of Native Plants and Animals under the **Crown Land (Reserves) Act 1978** by Order In Council dated 22 February 2000, published in the Government Gazette of 24 February 2000, page 319.

**West Wail Flora and Fauna Reserve**

Land in the Parish of Wail (now known as Allotments 196A and 196B) shown bordered red on plan marked W:26/9/1988 attached to Department of Conservation, Forests and Lands Correspondence No. Rs 13908 and being the land described in the Land Conservation Council's Final Recommendation F17 of the Wimmera Area-(Rs.13908), temporarily reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 11 July 1989, published in the Government Gazette of 19 July 1989, page 1783.

**William Hunter Flora Reserve**

Allotment 3 of Section 9, Parish of Orbost East, Township of Marlo, temporarily reserved for the Preservation of Native Flora under the **Land Act 1928** by Order In Council dated 5 June 1951, published in the Government Gazette of 13 June 1951, page 4038, and deemed under section 4(4) of the **Crown Land (Reserves) Act 1978** to be temporarily reserved under section 4(1) of that Act; and Allotment 48E of Section C, Parish of Orbost East, temporarily reserved for the Preservation of Native Flora under the **Crown Land (Reserves) Act 1978** by Order In Council dated 7 February 1995, published in the Government Gazette of 9 February 1995, page 306.

**Wises Creek Flora Reserve**

Allotment 2A of Section D, Parish of Talgarno, permanently reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 23 April 1991, published in the Government Gazette of 1 May 1991, page 1164.

**Won Wron Flora Reserve**

Allotment 1A of Section A, Parish of Wonwron, permanently reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 15 July 1992, published in the Government Gazette of 15 July 1992, page 1817.

**Wood Point Flora Reserve**

Allotment 20, Parish of Bete Bolong South and Allotment 22 of Section A, Parish of Bete Bolong North, permanently reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 18 November 1986, published in the Government Gazette of 26 November 1986, page 4495.

**Wood Wood Flora and Fauna Reserve**

Allotment 17 of Section 1, Parish of Piangil, Township of Wood Wood, permanently reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 25 November 1986, published in the Government Gazette of 3 December 1986, page 4584.

**Yanakie Flora Reserve**

Allotment 22A, Parish of Yanakie, temporarily reserved for Public Purposes (Native Flora & Public Recreation) under the **Land Act 1958** by Order In Council dated 20 March 1973, published in the Government Gazette of 28 March 1973, page 676, and deemed under section 4(4) of the **Crown Land (Reserves) Act 1978** to be temporarily reserved under section 4(1) of that Act.

**Yarck Nature Conservation Reserve**

Allotments 31, 31C, 32 and 32B of Section A, Parish of Yarck, permanently reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 24 August 1982, published in the Government Gazette of 1 September 1982, page 2878.

**Yarrangook Flora and Fauna Reserve**

Allotments 12A, 14A, 14B and 15B, Parish of Yarrangook, temporarily reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 1 February 1989, published in the Government Gazette of 8 February 1989, page 312; and Allotment 13A, Parish of Mahrong, permanently reserved for the Preservation of Species of Native Plants under the **Crown Land (Reserves) Act 1978** by Order In Council dated 5 May 1992, published in the Government Gazette of 6 May 1992, page 1079.

**NOTES**

1. A person who contravenes any one of these Regulations is liable to the imposition of penalties as set out in section 13 of the **Crown Land (Reserves) Act 1978**.
2. In addition to these Regulations the following laws also apply with respect to—

**Aboriginal Sites and Relics**

All archaeological sites and relics pertaining to the past occupation by the Aboriginal people of Australia are protected under Commonwealth legislation (**Aboriginal and Torres Strait Islander Heritage Protection Act 1984**). In Victoria a contravention of the **Archaeological and Aboriginal Relics Preservation Act 1972** may also result in the imposition of penalties under that Act.

**Fire**

In addition to regulation 27, the **Country Fire Authority Act 1958** and the Forests (Fire Protection) Regulations 2004 govern the lighting of fires. A contravention of that Act or those Regulations may result in the imposition of penalties under that Act or those Regulations.

**Firearms**

In addition to regulation 33, the **Firearms Act 1996** governs the possession, carriage and use of firearms. A contravention of that Act may result in the imposition of penalties under that Act.

**Fish**

Under the Fisheries Regulations 1998, it is an offence to stock fish into protected waters unless a person is authorised under the **Fisheries Act 1995**. A contravention of those Regulations may result in the imposition of penalties under those Regulations.

**Litter**

The depositing of litter in a nature conservation reserve is prohibited under the **Environment Protection Act 1970**. A contravention of that Act may result in the imposition of penalties under that Act.

**Motor Vehicles**

Under the Land Conservation (Vehicle Control) Regulations 2003, motor vehicles are prohibited from being within a nature conservation reserve except on a road, in a parking area or in an area declared to be a free access area. A contravention of those Regulations may result in the imposition of penalties under those Regulations.

**Non-Aboriginal Historic Places**

All archaeological sites and relics are protected under the **Heritage Act 1995**. A contravention of that Act may result in the imposition of penalties under that Act.

**Wildlife**

The taking, hunting or destroying of wildlife may result in the imposition of penalties under the **Wildlife Act 1975**.
