## Marine Act 1988

### SECTION 15 NOTICE

I, the Director of Marine Safety, on the recommendation of Stuart Ord, Regional Manager City and Bays, Parks Victoria, hereby give notice under subsection 15(1) of the **Marine Act 1988** that:

- (a) bathing and the operation of vessels are prohibited on the waters of the Yarra River between the upstream edge of the Bridge Road Bridge to the downstream edge of the Judge's box located opposite Alexandra Gardens between the hours of 10.30 a.m. and 4.00 p.m. on Saturday 27 November 2004, excluding vessels involved with the Head of the Yarra Rowing Regatta and vessels owned and operated by Parks Victoria.
- (b) the vessels involved with the Head of the Yarra Rowing Regatta are excluded from Clauses 3(a), 3(b) and 7 of Notice No. 1 made under S 15(2) of the **Marine Act 1988** for the period specified above.
- (c) At the completion of the event and as determined and announced by the Parks Victoria Ranger in Charge – Yarra River, the waters will revert to the provisions of Schedule 3 contained in Notice No.1 made under subsection 15(2) of the **Marine Act 1988**.
