



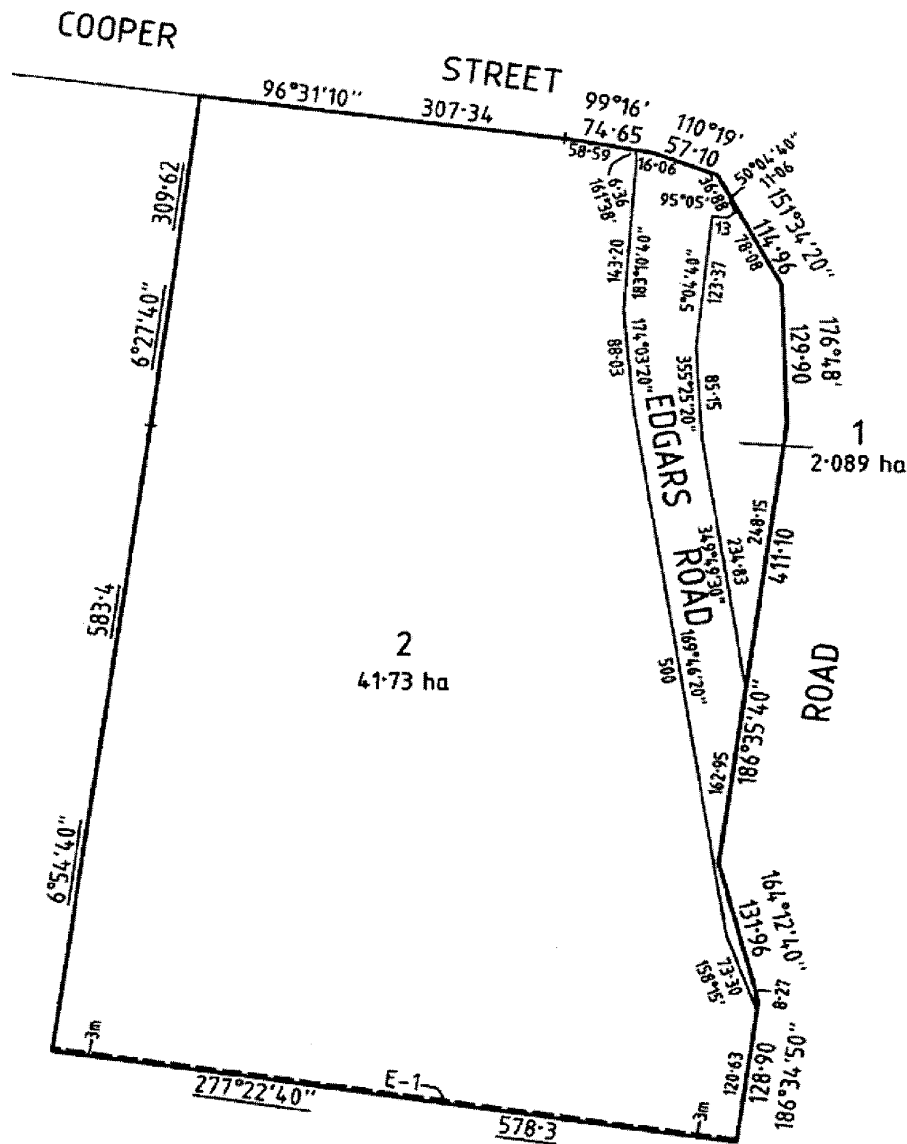

## Planning and Environment Act 1987 NOTICE UNDER SECTION 201I(3)

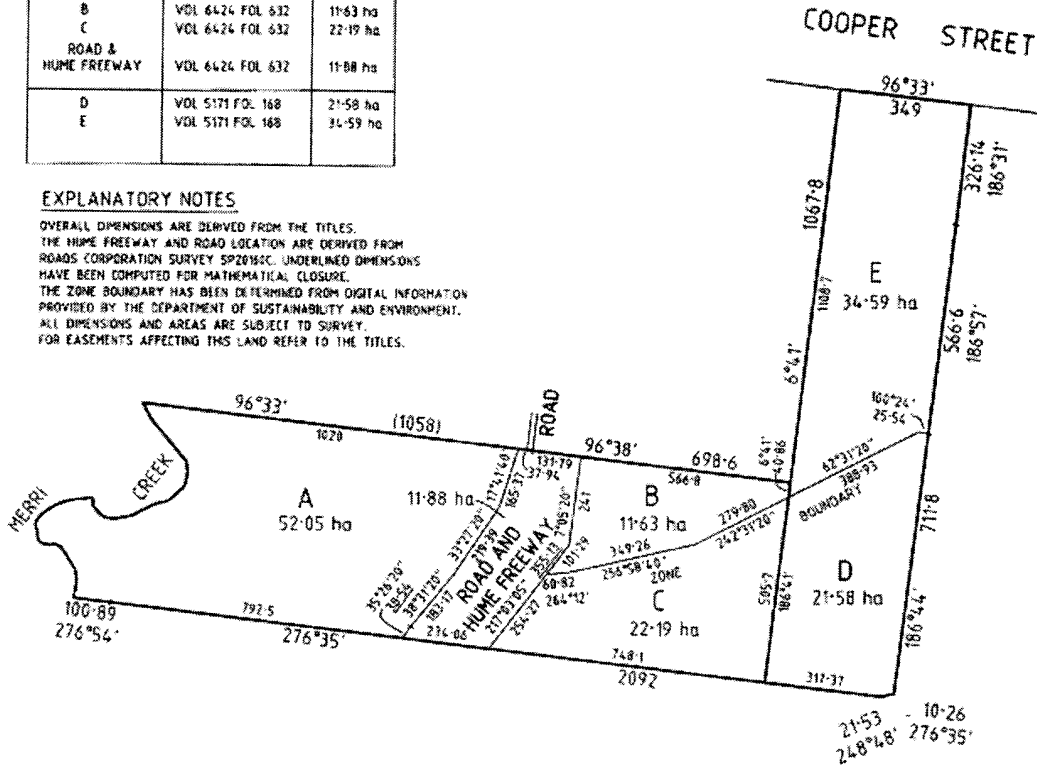
