#### Road Safety Act 1986

## ORDER IN COUNCIL DECLARING CERTAIN ELECTRIC SCOOTERS NOT TO BE MOTOR VEHICLES

The Governor in Council makes the following Order:

#### 1. Objective

The objective of this Order is to declare certain types of electric scooters not to be motor vehicles for the purposes of the **Road Safety Act 1986**.

#### 2. Authorising provision

This Order is made under section 3(2)(b) of the Road Safety Act 1986.

#### 3. Commencement

This Order comes into operation on the day on which it is published in the Government Gazette.

#### 4. Revocation

The Order in Council made under section 3(2)(b) of the **Road Safety Act 1986** on 26 August 1992 and published in the Government Gazette No. G 33 at page 2501 is **revoked**.

#### 5. Certain electric scooters not to be motor vehicles

- (1) The class of motor vehicle described in sub-section (2) is declared not to be a motor vehicle for the purposes of the **Road Safety Act 1986**.
- (2) A scooter that–
  - (a) can be propelled by one or more electric motors; and
  - (b) has a combined maximum ungoverned power output of all motors of less than 200 watts, and
  - (c) is capable, when ridden by an adult on level ground, of being propelled at a maximum speed not exceeding 10 kilometres per hour.

#### (3) In this section–

"scooter" means a vehicle (with or without a seat) that-

- (a) has either 2 wheels (one in front of the other) or 3 wheels (one in front and two at the rear); and
- (b) has a footboard between the front and rear wheels; and
- (c) is steered by means of a handle bar; and
- (d) can be propelled by one or more motors.
