ORDER DECLARING A RESTRICTED AREA IN VICTORIA FOR THE CONTROL OF QUEENSLAND FRUIT FLY DISCOVERED AT TOCUMWAL (NSW)

I, Bob Cameron, Minister for Agriculture, under sections 20 and 22 of the **Plant Health and Plant Products Act 1995** make the following Order declaring a restricted area for the control of Queensland Fruit Fly and specifying the prohibitions, restrictions and requirements which are to operate in the restricted area.

1. **Objective**

The objective of this Order is to declare a restricted area in Victoria for the control of Queensland fruit fly discovered at Tocumwal (NSW) and to specify the prohibitions, restrictions and requirements which are to operate in the restricted area.

2. **Authorising provisions**

This Order is made under sections 20 and 22 of the **Plant Health and Plant Products Act 1995**.

3. **Definition**

In this Order—

- (a) “**Act**” means the **Plant Health and Plant Products Act 1995**;
- (b) “**Queensland fruit fly**” means the exotic pest *Bactrocera tryoni* (Froggart);
- (c) “**Regulations**” mean the Plant Health and Plant Products Regulations 1996.

4. **Restricted area for the control of Queensland fruit fly**

The restricted area for the control of Queensland fruit fly is declared to be the area described in Schedule 1.

5. **Prohibitions, restrictions and requirements**

- (1) The removal from the restricted area into any part of Victoria of any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations is:
 - (a) prohibited unless the fruit or vegetable is accompanied by a Plant Health Certificate, Assurance Certificate or Plant Health Declaration; and
 - (b) in the case of fruit for treatment, packing or processing outside the restricted area, is accompanied by a permit issued by an inspector under section 21 of the Act.
- (2) Any fruit or vegetable listed as a host of Queensland fruit fly in Schedule 5 of the Regulations which is transported through the restricted area, from areas free of Queensland fruit fly, must be transported in accordance with the conditions of a permit issued by an inspector under section 21 of the Act.

Schedule 1

The area of land bounded by a line commencing at the point where Mookarrii Street intersects with the Murray River, then in a westerly direction along Mookarrii Street to the intersection of Mookarrii Street and Campbell Road, then in a southerly direction along Campbell Road to the intersection of Campbell Road and Pullar Street, then in a westerly direction along Pullar Street

which becomes Macarthur Road and then becomes Fowler Road to the intersection of Fowlers Road and Lorenz Road, then in a northerly direction along Lorenz Road to the intersection of Lorenz Road and the Murray Valley Highway, then in a westerly direction to the intersection of Murray Valley Highway and O'Briens Road, then in a northerly direction along O'Briens Road to the intersection of O'Briens Road and Bearii East Road, then in a westerly direction along Bearii East Road to the intersection of Bearri East Road and Rockliffs Road, then in a northerly direction along Rockliffs Road to the point where Rockliffs Road meets the Murray River, then in an easterly direction along the Murray River to the point of commencement.
