CASINO RULES NOTICE NO. 6 OF 2004

Rules of the Game—Blackjack

By this notice, the Victorian Casino and Gaming Authority **amends** the Rules in respect of the game “Blackjack”¹ as set out in the Schedule.

This notice operates with effect from 4.00am on 19 March 2004.

Schedule

1. For rule 11.7.3(b) **substitute** the following rule—
 - (b) Where an electronic failure, which cannot be rectified at the time, occurs during a round of play, winning Pontoon Pandemonium wagers will be settled with a payout that is equivalent to the minimum Pontoon Pandemonium payout for the particular pay table in use as described in rule 11.6.3.
 2. For rules 15.4.2 and 15.4.3 **substitute** the following rules—
 - 15.4.2 A player may place one or more Perfect Pairs wager/s on any Perfect Pairs betting area provided that there is a valid Blackjack or Crown Blackjack wager placed in the betting area corresponding to the Perfect Pairs wager.
 - 15.4.3 A maximum of three Perfect Pairs wagers may be placed on a Perfect Pairs betting area. A player/s that has placed a valid Blackjack wager on a specific betting area will have first entitlement to place a Perfect Pairs wager in the corresponding area for Perfect Pairs wagers.

1. The full set of Rules for the game of Blackjack was most recently approved by the Victorian Casino and Gaming Authority by notice published in the Victorian Government Gazette on 5 February 2003 (S18). The rules have subsequently been amended by —
 - Casino Rules Notice No 10 of 2003 published on 22 May 2003 (G21);
 - Casino Rules Notice No 13 of 2003 published on 10 June 2003 (G 28); and
 - Casino Rules Notice No 3 of 2004 published on 12 February 2004 (G7).
