Commonwealth Games Arrangements Act 2001 COMMONWEALTH GAMES PROJECT ORDER

In accordance with section 15 of the **Commonwealth Games Arrangements Act 2001** ("the Act"), as Minister administering the Act, I declare the Yarra Precinct Pedestrian Link a project to develop facilities at a Commonwealth Games venue to be a project to which the Act applies and I authorise the development of that project for the period commencing 1 April 2004 until 31 March 2006.

In accordance with sections 17 of the Act I specify that the Secretary to the Department for Victorian Communities, being a body corporate constituted under section 25A of the Act, as the body responsible for managing or developing the Commonwealth Games project to which this Order applies.

This Order shall take affect from the date of its publication in the Government Gazette. Dated 30 March 2004







This Order shall take effect from the date of its publication in the Government Gazette. Dated 30 March 2004


