GUARANTEE OF BOOKMAKERS AGAINST DEFAULTS IN PAYMENT OF WAGERS

Order in Council

The Governor in Council under section 94A(2B) of the **Racing Act 1958**, and on the recommendation of the Minister for Racing amends:

the Order in Council dated 24 September 2002 by deleting the following words in Table 2

#### "future win/place" means—

- (i) a bet made by the nomination of a horse or greyhound on the chance that such horse or greyhound will fill first place or fill first, second or third place in a specified race providing that the race is decided at a race meeting conducted on a day after the day the bet is placed; or
- (ii) a bet made by the nomination of a horse or greyhound on the chance that such horse or greyhound will fill first place in three specified races;
- (iii) but does not include a bet made when a bookmaker is operating under a club betting permit issued by the Minister.

and inserting the following words in Table 2

## "future win/place" means-

- a bet made with a Bookmaker who is authorised by Racing Victoria Limited, Harness Racing Victoria or Greyhound Racing Victoria (as the case may be) to accept future win/place bets; and is
- (ii) a bet made by the nomination of a horse or greyhound on the chance that such horse or greyhound will fill first

place or fill first, second or third place in a specified race providing that the bet is made no later than 30 minutes prior to the advertised start time of the race on which the bet is decided: or

- (iii) a bet made by the nomination of a horse or greyhound on the chance that such horse or greyhound will fill first place in three specified races;
- (iv) but does not include a bet made when a bookmaker is operating under a club betting permit issued by the Minister.
