- (b) is subject to a condition that all prohibited weapons the subject of this Order must be safely and securely stored in an approved Victoria Police facility at all times except when being used for training or educational purposes or whilst being transported for official Victoria Police purposes. Prohibited weapons must be kept in a safe and secure manner in accordance with relevant Victoria Police guidelines, whilst being transported.
